We had a great turnout from MOAA National led by Gen Gary North (USAF, Ret), Chairman of the MOAA Board of Directors. For those that participated, I know you went away better prepared to serve our members and engage in your communities. We will also meet with Congressional Representatives and staffers in their local offices over the summer to convey our support to MOAA's legislative agenda on behalf of the serving military, veterans, and their family members. Our legislative team will be providing more information on our legislative push and providing instructions on how chapters and members need to support the effort. Taxes and Paperwork

It's that time of year. 1099s and tax forms start showing up in the mail and on websites. Your tax preparer sends you the "tax planner" and asks you to sign the "engagement letter." You'll get all your paperwork together and get it in. You'll get back either a form that allows the tax preparer to electronically file your taxes or file an extension. At some point, you'll get back an envelope with a copy of the tax form and the source documents that you gave the tax preparer.

So... how long should you keep the paper? Actually, how long should you keep all paper?

Hopefully, you have all monthly bills set up for electronic delivery. If so, the question regarding monthly bills is moot. If not, once you've paid your electric bill, your phone bill, your cell bill, and the payment shows on the next one, you can shred the original bill.

Assuming you're doing e-delivery, bank and credit card statements can be accessed electronically, so you need not save these, too.

What about all the tax papers? Most accountants will tell you to keep these seven years. Some.. will say less.

When you file your taxes, the IRS will either deposit your check or send you a refund fairly quickly. But it's really about a year to eighteen months before they even look at your tax form. (Maybe longer nowadays...) If there's a question or a problem with your taxes, you should hear about it within two years of filing. Pretty much, if they have not questioned a return within three years, they most likely won't. The exception is if they suspect fraud. There's no time limit on that, so if you intentionally tried to defraud the government, you should keep documents *forever*. But, if you are honest, three years is most likely good enough.

As I get ready to have my 2022 taxes done, I keep the files containing my 2021, 2020, and 2019 documents, and shred the 2018 papers.

Very few people are actually audited. My tax preparer says that she's never had a client do complete audit in her career and she's been doing my taxes since the mid-nineties. But... she gets to respond to dozens of *letters of deficiency* every year. These inquiries normally pertain to a single or a few transactions. (Most people *think* they are being audited when the get a deficiency letter.)

Interestingly enough, when a person gets a letter of deficiency from the IRS, the first thing they normally do is connect with the tax preparer. If they need any documentation, they normally get it from the bank. It's actually pretty rare that anyone goes digging through piles of paper to find a



receipt.

Nothing good comes from retaining piles of paper. Besides the fact that finding a specific document a couple years later is pretty challenging, more often than not, somebody else ends up disposing of it. And as people get older, the need for help in-the-home increases. The likelihood of an unvetted cleaning person finding a document with an account number on it is undoubtedly much greater than that of an IRS audit. Basically, any piece of paper you *don't* have... cannot disclose an account number to a criminal. *If in doubt, throw it out.* (Really, *shred it.*) If you ever need a document in the future, you can probably get it.

One big exception to shredding is any document showing what you paid for your home and any capital improvements. Maintenance doesn't count, but if you added a garage or pool, you'll likely need the bills to determine your cost basis of the home.

The other big exception is if you run a business. You'll need a ton of paperwork and need to keep it. Just do as your accountant suggests. It will probably entail more *stuff* for longer periods of time.

But if you are retired military, and have another source of income or two that are totally out in the open, your need to keep paper goes down dramatically.

Incidentally, with respect to having your taxes done, you have several choices:

CPA: A Certified Public Account is a highly trained individual who has passed the CPA exam and remains current with CPA Continuing Education. A CPA (and a tax attorney) may represent you in disputes with the IRS.

EA: An Enrolled Agent is also highly trained and passed a rigorous exam, the big difference between a CPA and an EA is that a CPA can certify a *business audit*. An EA cannot. But, an EA may also represent you in disputes with the IRS.

Tax Preparation Company. Companies such as H&R Block and Jackson Hewitt can do your taxes relatively inexpensively. Of course, the education requirement of an H&R Block tax preparer is not too high. Basically, they teach an eight week tax course and then offer jobs to the top performers in the class. Keep in mind that they do a lot of tax forms for a lot of people.

Tax Prep Software. Turbo Tax is offered everywhere and is surprisingly easy to use. It is relatively inexpensive and quite intuitive. There are other versions. I'm sure they are effective, too. **Do it Yourself**: It's still legal to do your own taxes and some people do it by hand, but the error rate on individually done tax forms is *huge*. I would bet that when the IRS gets around to looking at DIYs, they look closely. Very closely.

So which should you use? *It depends*. The more complicated your taxes, the more training and experience your tax preparer needs.

If all of your income is visible (government, corporate, bank, investment firm), pretty much any of the tax preparers can do it. As you sources of income get more complicated, you'd be better off going higher on the list. Do you get a K-1 from a private investment? Now it's a little complicated. Do you run a business? Or claim a home office? You should probably consider an EA or CPA.

Personal experience: I've been using an Enrolled Agent for decades. She's extremely competent and I've had only a couple IRS deficiency letters. In both cases, I paid nothing additional. As near as I can tell, the only difference between my EA and a CPA is she's slightly less expensive than a

typical CPA. But if you have multiple sources of income, and own lots of commercial real estate or businesses, you should probably be on a first name basis with a CPA.

I also use Turbo Tax. I do the taxes for the grandkids, who have college accounts that generate taxable income, and occasionally do the taxes for some friends who have very simple tax situations. Turbo Tax is very simple to use. It asks you questions and you answer. It can download much of your data so you need not spend much time doing data entry. I also use it to print the extension that I usually get. (My EA says that I'm her only client who does his own extension...) If you can order something from Amazon, you can use Turbo Tax.

The most important thing you can own with respect to taxes is... a *shredder*. All it takes is one document with your SSN on it falling into criminal hands and you'll wish you had spent forty or fifty bucks on a shredder. Your local UPS Store will do "bulk" shredding too for a few dollars a pound. It's worth it if you have bags of documents to shred. I'd bet most people do...



Surviving Spouse Corner

Welcome to 2023! As of this month, there is no longer a SBP/DIC offset. You also should have received your COLA (cost of living adjustment) to your military and Social Security benefits.

As you receive important tax documents, immediately check them for accuracy. Corrections can take a few months so get started as soon as you can. Keep all these documents in a folder in preparation for taxes.

2023 is a year that may have an impact on retirees and surviving spouses. Look in your November 22 MOAA Magazine on page 87. Listed there are rule changes for SBP and the remarriage age for DIC benefits.

Another big change this year is that an Open Season for SBP began and ends on January 1, 2024. For the retiree who paid into the annuity for a deceased spouse, the annuity can be reopened for the current spouse by paying back premiums and resuming annuity payments. A special webpage has been constructed for details, news and information. Go to www.dfas.mil/sbpopenseason23. These changes may not apply to you, but pass the information on.

The MOAA Florida Council did a great job in leadership training at the Rosen Center in Orlando. I was so pleased that 5 SS Liaisons were in attendance. I understand that for some of you it is a great distance to come, or the timing might not be right. Consider asking someone representing your chapter to pick up handouts for you or take notes. Lots of information was introduced. The slide show will be attached to the www.moaafl.org website.

Did you make a New Year's Resolution? How is that working for you? I dropped resolutions long ago...no real successes. Instead, I plan to focus on an improvement that I can make. This year, I

Congressional Report Aims to Cut Deficit, But Would Cost Retirees Thousands

The Congressional Budget Office (CBO) provides a 10-year overview of deficit reduction measures once every two years, before the start of a new congressional session. As with past years, the report includes ways to reduce both mandatory and discretionary funding, as well as ways to increase federal revenue ... but it does not consider any long-term implications of these potential savings, nor the impact cuts would have on affected communities or on significant challenges facing the nation, such as military recruitment and retention.

The recent report from the CBO includes several proposals which could weaken or eliminate earned benefits for nearly all members of the uniformed services and veteran communities. These proposals, if enacted, could cost servicemembers past and present – and their families, survivors, and caregivers – thousands of dollars every year.

- Retirees and survivors would face TRICARE For Life enrollment fees and increased medical costs, and receive smaller cost-of-living increases for their retirement pay and survivor benefits.
- Veterans would see significant reductions in available VA care and reduced benefit payments.
- Servicemembers and their families would suffer from a cap on pay raises and cuts to a critical housing benefit.

MOAA has identified 13 options from the CBO report which could inflict such harm; we will continue to fight for our constituents to ensure proposals like these are not enacted, or even considered. We need to let Congress know where beneficiaries stand on these issues. Watch The MOAA Newsletter and MOAA's Advocacy News page for ongoing updates throughout the year for an

opportunity to tell Congress what you think about the CBO's ideas to increase out-of-pocket costs for Tricare For Life beneficiaries, especially in the face of recent cuts to the TRICARE retail pharmacy network.

MOAA - Congressional Report Aims to Cut Deficit, But May Cost Retirees Thousands

A Strong Start Is Critical to the Success of the Major Richard Star Act

Over two-thirds of the 117th Congress supported the bipartisan and bicameral Major Richard Star Act during the 117th Congress. The act would provide concurrent receipt of DoD-earned retirement pay for years of service and VA disability compensation for over 50,300 combat-injured veterans. Currently, these combat-injured (and often seriously disabled) veterans lose a dollar of retirement pay for every dollar of disability pay received – an unjust offset designed to save the government money. The bill achieved 336 co-sponsors in the House and 67 in the Senate, yet failed to receive a vote in either chamber.

The list of original House co-sponsors in the 118th Congress topped 160 at the end of January. The next milestone is to reach 290 co-sponsors before any other piece of legislation, making the bill first on the House Consensus Calendar, which opens March 1 with the new rules for the 118th Congress. Entry on the House Consensus Calendar can drive early negotiations for the bill, as the House must also grapple with rules for budgetary control.

The Military Coalition recently published a letter urging the members of the 118th Congress to sign onto the Major Richard Star Act. The House and Senate versions of the bill are expected to be officially reintroduced in mid-February, so there is still time to get your elected officials signed on. Florida Department of Veterans Affairs Update

Operating as the premier point of entry for Florida's 1.5 million Veterans, the Florida Department of Veterans' Affairs operates a network of nine State Veterans' Homes and provides statewide



outreach to connect Veterans with their earned services, benefits and support. It's a team effort, and I'm grateful for the support our department has at all levels.

With the beginning of the new year, Gov. Ron DeSantis and the Florida Department of Veterans' Affairs (FDVA) are highlighting a number of policies and initiatives providing critical support to our state's veterans, their families and survivors. FDVA is a nearly 1,500-member constitutionally chartered State Veterans' Affairs department with a \$171 million annual budget responsible for serving the nation's third largest veteran population.

Operating as the premier point of entry for Florida's 1.5 million veterans, FDVA operates a network of nine state veterans' homes and provides statewide outreach to connect veterans with their earned services, benefits and support.

The agency's veterans' claims examiners play a major role in the direct infusion of more than \$23.9 billion annually for veterans into Florida's economy through federal compensation, education and pension benefits, U.S. Department of Veterans Affairs' medical services and military retired pay. The 2023 Florida Legislative Session begins on March 7. In preparation for the 60-day session, the legislature is meeting in a series of Interim Committee Weeks, discussing key legislation which may impact our state's Veterans. My senior staff and I have spent the past several weeks testifying before committees responsible for Veterans issues in Florida. You can follow the week-to-week discussions by visiting our website at www.FloridaVets.org and clicking on "Veteran Legislation."

Major General Haas is the Assistant Adjutant General – Army and the Commander of the Florida Army National Guard. Prior to assuming his position, he was the Director of Strategic Plans, Policies, and Programs for the Florida National Guard. General Haas has completed three combat tours and held multiple company-level commands. Haas will become the Adjutant General of Florida upon the retirement later this year of Maj. Gen. James O. Eifert.



<u>Judge Alicia L. Latimore</u>, Ninth Judicial Circuit, and <u>Lisa Vargas</u> presented a talk on the Orange County Veterans Treatment Court Program on Tuesday. Judge Latimore is a native Floridian, born and raised in Miami, Dade County, Florida.

As of January 1, 2021, she serves as the Administrative Judge for the Ninth Circuit Problem Solving Court division where she presides over a total of nine treatment courts for Orange and Osceola counties including Early Childhood Court which she helped to implement in her circuit in 2015.

Veterans returning from combat may suffer from post-traumatic stress disorder or may have difficulty reintegrating into society. Due to alienation and lack of support, some veterans fall into drug and alcohol abuse or develop mental



health issues. Veterans Courts have been established to address these issues.

Across the United States, successful completion of Veterans Court has helped decrease the recidivism rates of its participants through the proper diagnosis and treatment of mental health issues and as a result of the supportive roles mentors play in the process.



Status from Indian River Chapter FL 36 MOAA on our largest project yet.

At IRC – MOAA Chapter we have made special efforts to meet all of our goals as a 5 Star Level of Excellence Chapter. We have become proficient in increasing our visibility by continuing to complete all of our standard missions each year. This includes JROTC involvements, Leading the IRC Veteran's Council's Veterans in the Classroom Programs, Veterans Helping Veterans and Veterans Outreach, Gold Star Mothers and Veteran Organizations causes as well as Scholarships, Mentoring, community involvement with the cities and county commissions, staffing our officers as board members on the IRC Veteran Council, leading Veterans Day, Memorial Day and other Veteran – Community joint ventures. Offering our Veteran Speaker Programs to organizations and other community entities. We are everywhere and people know us.

Two years ago our MOAA Chapter took on a new and somewhat different challenge and we accomplished it with no impact to our standard activities. IRC-MOAA took on the lead to erect a WW1 Doughboy monument on our Veterans Memorial Sanctuary Island. We are very fortunate to have such a beautiful and meaningful site unlike no others. The Island was created by the dredging of the Intracoastal Waterway and a returned WW1 Officer Lt. Alec McWilliam, native of Vero Beach thought it would make an excellent veterans venue. So he pursued the city and county officials and they complied. He was right and this beautiful site developed as a sanctuary. Since 1963 several simple but meaningful symbols of service have been tastefully added such as a stone and plaque to each military service, recognition of POWs, Korean War, Vietnam, the more recent "Desert Wars", fallen local veterans and local organizations. But it was missing two very important events: World Wars One and Two.

So in 2020 IRC- MOAA accepted the lead and appointed two of its senior officers USMC (Ret) Colonel Mike Discipio and USAF (Ret) Colonel Carlos Halcomb to give recognition to WW1. They accomplished this goal in a short 8 months, raising interest, money and erecting the WW1 Doughboy whom we reverently refer to as LT Alec.

It was dedicated on Veterans Day 2021 but MOAA kept right on rolling with a much larger and expensive World War Two Tribute. We formed a four person Tribute team to lead the charge. IRC-MOAA Officers Army Colonel (Ret) Tony Young, a native of Vero Beach and former mayor and Army (Ret) Lt. Colonel Carroll Oates, then Chapter President as well as USMC Sgt. John Michael Matthews, Chairman of the Sanctuary Committee and member of the Veterans Council and the civilian daughter of a WWII Veteran, Barbara Ruddy, took on this new challenge.

Known as the WWII Tribute Team they gave serious thought to what was needed and instead of a statue or monument the Tribute will be a much needed permanent reviewing stand with many references to the War and The Greatest Generation. After all, Indian River County had a very intimate relationship to that war. The Vero Beach Naval Air Station was located only a mile or so from the Island. The Navy and Marine Corps trained pilots, mostly fighter bombers, there and over a hundred pilots lost their lives during that training. Their motto / Logo was the Buccaneer which the





Team has taken on as its symbol and IRC-MOAA has named its monthly newsletter "The Buccaneer".

Progress is being made and we are almost 2/3rds of the way there with the needed funding. Most preparation and engineering work has been accomplished and our desired objective is to have the dedication on or near Veteran's Day 2023. In fact IRC-MOAA is holding a fundraiser event on February 18th to help with the cost. We have also partnered

with the IRC Cultural Council who, as a 501(c)3, is taking care of the financial aspects and assisting with countywide promotions.

The Team has created several promotional videos, made many presentations and worked with other veteran organizations in the county to conduct fundraisers. The family of one WWII veteran was so inspired they donated \$100,000 in his name and we are on a roll towards our goal.

The parade reviewing stand will become the centerpiece for the island. Besides providing an event stage it will contain various WWII symbols such as the WWII Victory Medal, Campaign Ribbons, a learning kiosk and much more. And our Military Officers Association will literally be cemented as the leader for the recognition to our veterans and our county's patriotic involvement to their service and sacrifice. As officers we take the lead and accomplish our missions always Still Serving.
