Mary and I will be attending the Georgia convention at Ft. Benning 7-10 October, with Mike and Diana. It will be great to see good friends Biff and Trish Hadden and the Georgia Council leadership again. I'm looking forward to all the events at Ft. Benning.

The following week 15-16 October Mary and I will drive up to D.C. for the MOAA National convention. Mike and I will receive the LOE awards and I'll bring them back so they can be awarded to Chapters at the 7-8 January 2022 Leadership Training Seminar in Orlando.

World Affairs: Mary and I returned to our home in Fleet Landing in Atlantic Beach late on Wednesday 29 September from a Viking river cruise that started in Bucharest, Romania on 7 September and ended in Amsterdam the same day we returned. Of course we saw churches, palaces and museums but the most striking were the stories of our guides in the former soviet states about life under communism - living in "commie condos", the shared misery of "socialist realism", and the distain for the privileged party elite from 1944 to the fall in 1989. Even more striking were the stories of the turmoil of reverting to democratic republics and returning land and homes to owners after 45 years of state ownership. Fields lay untended for up to 15 years while ownership was established followed by new owners without the needed skills or machinery to farm the land. Homes were still in disrepair in 2021 in historic city areas because owners could not be identified or would not return, and the heritage buildings could not be sold or taken over by the city. As the leader of Yugoslavia Tito brought relatively good times, but failed to groom a successor. So when he died in 1980 Yugoslavia broke apart into several states, some who went to war in the 1990's with unexpected atrocities between Serbia and Croatia - we heard different perspectives



from guides from both sides. I wish young Americans could hear these stories about the shared misery of socialism and communism so they would be better informed about the dangers of going down that road.

However humor is still alive there - from a guide across the river from Bavaria:

What do you call a good looking lady in Bavaria? - Answer: Tourist

From a guide in Hungary about the infamously bad car the Yugo:

What is it if you see a Yugo on top of a tall hill? Answer: A miracle - O.K how about if you see two Yugo's on top of a tall hill? Answer: A mirage.

All of the countries we visited had a little different protocol for handling COVID precautions, but Viking helped us understand the procedures, tested us almost every day, and we felt very safe on all of our travels during our trip.

# **Chaplain's Message**

To everything there is a season, and a time for every purpose under heaven. Ecclesiastes 3.1

For me, the Raintrees' yellow blossoms and pink blooms signal the arrival of autumn in Florida. Coffee shops brew the pumpkin spice, breweries tap the Oktoberfest, and college football dominates Saturday TV. The air seems a bit drier and, on some mornings, maybe even a bit cooler than the dog days of summer.

We can mark and notice the passing of the seasons through events and days on the calendar. On a deeper level, though, life takes us through different seasons as well: seasons of work, seasons of illness, seasons of joy, seasons of sadness.

A most difficult season of life to navigate is a season of transition because that season of transition often involves waiting. And let's face it; most of dislike, even hate, waiting. Whether it's for the doctor, for traffic, or the microwave to ding. We don't want to wait.

# **Membership Chairman**

In the past two *Communiques*, we discussed growing our membership numbers State-wide to make an even larger impact. In June, the membership topic was the "Target Rich Environment" we live in as Florida is

the #3 state in the Nation with resident veterans. In August, we introduced the three Lines of Effort or LOE for conducting a Membership Campaign: (1) Retaining Current Chapter Members, (2) Recruiting New Members, and (3) the internal and external Public Relations effort to "get the word out". Now let's dive into LOE #1--Retaining Current Chapter Members.

LOE #1 reflects everything your chapter is doing or needs to do to keep current members <u>and</u> attract new members. You have probably found that recruiting new members is HARD, but retaining current members is even HARDER! Every member you keep is one less that you need to recruit. Ask yourselves these questions: Why would someone want to join your chapter? Does your chapter provide services and philanthropy in your local community? Does it do things for your members and are you organized to help members, be they



veterans, spouses, or even family members? Take a critical look at your chapter--Does it have a purpose for being or what we in the military call "a mission"? Basic mission activities that each chapter should be performing fall into the areas of Legislative Advocacy, Community Service and Philanthropy, and a special Camaraderie with fellow members as you go about this important work.

- Being affiliates of MOAA National, our common mission is to support MOAA's Legislative Advocacy efforts, but we need to also be doing this at the local-level, and in conjunction with the Florida Council, at the state-level.
- Giving back to your community by conducting a variety of community service and charitable giving activities.

### Reasons to Join a Chapter

You know the value of belonging to your chapter and MOAA. But when you are talking to a potential new chapter member, it's important to remember that many officers might have only limited knowledge of MOAA and the MOAA chapter system. Creating a dialogue and asking open-ended questions is the best way to find out if and how a chapter membership could help a prospective member. Find out as much as you can about their priorities to tailor a response that is more likely to resonate with them personally. Here are some aspects of membership that may appeal to them.

- **1. Make yourself heard.** MOAA's chapters provide critical grassroots support for MOAA's national legislative agenda. Chapter members let their legislators know what's on their minds and open doors for MOAA's legislative team in Washington, D.C.
- **2. Give back to the community.** Chapter members are MOAA's ambassadors in their communities, supporting countless programs that make a difference in the lives of others. These members continue to serve and are giving back in the truest sense.
- **3. Value added to chapter members' lives.** MOAA chapters sponsor interesting programs and opportunities to interact with civic, political, military, and business leaders on issues important to members.
- **4. Networking with fellow officers.** Chapters include second-career members in the work force and retired servicemembers who have contacts in their communities that can be valuable to transitioning officers.
- **5. Stay informed.** Chapter newsletters, websites, and meetings provide you with the latest information on local, state, and national issues and changes to military benefits.
- **6. Influencing state and local legislation.** Most states have a council of chapters that unites chapters in the state. These councils, and independent chapters in states without a council, often lobby for and pass state-level legislation that affects military members and their families, such as exempting military retired pay from state income tax or increasing funding for state veterans' programs.
- **7. Camaraderie with a purpose.** MOAA chapters unite active duty, former, and retired officers from every branch of service, including National Guard and Reserve, as well as surviving spouses, offering the opportunity to connect with others with similar backgrounds and interest and develop close and lasting friendships.

MOAA's *Advocacy in Action* Campaign — Status Update



### <u>Congress Passes Continuing Resolution on Eve of Government</u> Shutdown

The House passed its Continuing Resolution Bill **HR 5305** extending funding at the FY 2021 levels to keep government operations running until December 3<sup>rd</sup>, and thus setting the stage to avoid a shutdown on September 23<sup>rd</sup>.

The Bill also contained provisions for supplemental Disaster Relief monies, supplemental funding for assistance to ongoing actions dealing with the Afghanistan refugees, and an extension of the Debt Limit to preclude the US Treasury from defaulting on its obligations. It passed on a strictly party line vote of 220-211, and sent to the Senate the next day.

The Senate amended this Bill to eliminate the provisions for extending the limit on the National Debt, and passed it September 30<sup>th</sup> on a vote of 65 - 35. Fifteen republicans supported this Bill including Senate minority leader McConnell, and the four Senators from LA and SC, both areas devastated by storms this year. Senators Rubio & Scott were both among the 35 nay votes.

Because of the changes made in the Senate, the Bill required a second vote in the House which took place later the same day. It passed on a vote of 254 -175. With a vacancy still open in District 20, the Florida delegation vote was 13 yeas (10 Ds – 3 Rs) to 13 nays (all by Republicans). ### **House Passes FY 2022 National Defense Authorization Act**

Also on September 23<sup>rd</sup> the House passed its NDAA for FY 2022 - HR 4350, on a bi-partisan vote of 316-113. There were 6 members of the Florida delegation who voted against this bill: Congressmen Rutherford (District 4), Posey (8), Webster (11), Steube (17), Mast (18), and Donalds (19).

Here are highlights on the House and Senate versions of the NDAA, which includes some of the MOAA-backed improvements to military pay and benefits:

A 2.7% military pay raise is included in both the House and Senate bills



Some lawmakers have noted the increase does not keep up with inflation. This raise remains tied to the Employment Cost Index (ECI) but fails to address a pay gap of 2.6% when pay raises fell below ECI in 2014-2016 because of budget sequestration.

- Provisions from the Military Hunger Prevention Act are included in both versions of the NDAA this year that will authorize a new allowance for families that fall within a band of the local poverty line. The House version is stronger than the Senate
- TRICARE Young Adult parity, did not make it into the House or Senate NDAA versions and will remain a MOAA priority next year.
- Concurrent Receipt, addressed in the Major Richard Star Act (H.R. 1282-introduced by Cong Bilirakis; FL-15), did not make it into the House NDAA. However, the Senate sponsors will submit their Bill (S 344) as an amendment to the Senate version of the NDAA later this month. It remains important for MOAA members to reach out to your lawmakers and ask them to sign onto H.R. 1282 and S. 344, as co-sponsors in order to ensure those Bills will roll over to the next legislative session for consideration.

- The House version of the NDAA requires a joint report from DoD and the VA on the next national cemetery and voices concern over eligibility changes for Arlington National Cemetery that would force those who have made burial plans to choose a different cemetery or cremation. An amendment to the Senate NDAA is expected from SASC member Sen. Richard Blumenthal (D-Conn.), who shares the concern of reducing this benefit.

When the Senate finishes its work and votes on their NDAA, we will have another chance to weigh in as the Joint Conference Committee meets to reconcile the inevitable differences between the House and Senate versions. And once again when the JCC returns it back to both houses for a final vote. Keep on watch for any news and MOAA calls-to-action as this important legislation meanders through the legislative process!

### **An Important Lesson Learned**

In a conversation as recently as September 28<sup>th</sup> a Congressional staffer reported to a MOAA staffer that "We did not have constituents reach out or write in to us that we have on record" requesting support for and co-sponsorship of the Major Richard Star Act (concurrent receipt for medically retired military).

This prompted the MOAA staffer to write to me asking "are there MOAA members from congressional district XX who can reach out to [him on this matter"?] I have deleted the Congressman's name as it could have been ANY district in FL.

I sent out a message to the FCoC Area VP that covers chapters in that district requesting they "get out a message urging the congressman to sign on to co-sponsor the bill" with a comment saying that I find it hard to believe there were no messages to this congressperson from Florida MOAA members (and as it turned out that was the case.)

FCoC President Mike Borders sent this message to the MOAA staffer: "For the record, I sent such letter to their office. More than once. In fact, several times."



That message was forwarded to the congressional staffer, who replied "I had our Legislative Correspondent check for any emails on this request and he found a *few* in our general email address."

More importantly he passed on this advice which should be helpful to all of us when communicating to our elected officials: "For constituents reaching out to our office, the best method of communication is to email us through [the official congressional web site]. This is the best way for the office to keep track of how many constituents write in about specific issues or bills."

The lesson to be learned from this is to use multiple means of communicating when advocating for our important legislative agenda – phone calls to both the District and DC offices; email via the links in MOAA's Calls-to-Action; emails using the congressional web site "contact me" links; and sending snail mail to the District offices. Any mail they receive addressed to the congressperson is faxed to DC.

The "Legislative Correspondent" (usually an intern) keeps track of the number of hits for and against every issue/bill that comes into their office and for the most part is reported internally every day. Repetitive correspondence from constituents boosts those numbers and raises the awareness of the staff and legislator to the message in that correspondence.

### **Additional NOTES:**

I reported on the co-sponsorship status of this Bill in my column on page 9 of the August FCoC *Communique*.

And on August 27th I emailed a **Special FCoC Legislative Call to Action** to all Chapter presidents requesting we double up our efforts to overcome the disappointing number of co-sponsors from our congressional delegation on the three topics in MOAA's **Advocacy-in-Action Campaign.** 

We have not seen any changes in co-sponsorship from the Florida Congressional delegation since that early August report.



# **Personal Affairs**

**Personal Affairs: ID Cards** 

The Department of Defense is in the process of replacing the current paper based Uniformed Service ID cards with modern, plastic ID Cards called "Next

Gen USID Cards." The new ones include special features that make them more difficult to counterfeit. Though the process was delayed by Covid, if you currently have a military ID, you should now be able to get a new one.

If your card includes an expiration date, you might consider arranging the new one at that time. If



your current card says "indef," you'll need to do it by January 2026. For many couples, one spouse has a retired ID that says "indef," and the other (non-veteran) spouse has an ID with an expiration date. When you get ready to do the non-veteran spouse ID, I'd just schedule both at the same time. If it's just you with an "indef" card, I'd wait until this Covid thing is finally on the wane.

Kind of like it was when the Covid vaccines first came out, the best way to get an ID card is by setting up an appointment *online*. Simply go to idco.dmdc.osd.mil/idco/ and register. (You have to wonder why the DOD doesn't spring for a website such as *get-new-ID-card.mil?...*)

When you go to the site, it asks you to put in your zip code. Having just moved to Longwood, just north of Orlando, I'm unfamiliar with any potential places, so this was a good drill. I put in my new zip code and found out that there are no ID facilities within ten miles.

I increased the radius to 25 miles and three showed up. The first one I picked was 16 miles away. I checked it's calendar. They were booked solid for thirty days.

Note-to-self: set up the appointment at least *two months* prior to when you need it.

Back in the nineties, I was the CO of the Marine Corps Reserve unit in West Palm Beach. I was also pretty active in the community and knew lots of veterans. Invariably, an acquaintance would call me personally asking if I could get him in quickly for an ID card. (It was almost always a *colonel....*). It drove me nuts because it always inconvenienced somebody; either the Corporal who got pulled out of training to do it or the other veteran who was bumped in line.

The point is... use the system and register online.

There's another advantage: when you register online, you fill in all your information and when the admin person goes to actually produce your card, all they need to do is verify your current IDs and click "print." (If your name happens to be *Borders*, it probably doesn't get screwed up very often. Not so, if your name is *Loschiavo*.)

When you register online, it will tell you what to bring - basically two government issued IDs. Your unexpired Military ID can be one of them, but it has to be *unexpired*. Make sure you get it right. Marine Corps corporals are not exactly known for their sense of humor.

The last time my wife and I went for a new ID, we registered online. The appointment was about six weeks out, but when we walked in, both of us were done in less than ten minutes. Easy peasy. Now, I wonder... is the new card the same size as a credit card?

That... would be pretty neat!

## Florida Legislature Meets in Preparation for 2022 Legislative Session

**TALLAHASSEE** – The Florida Legislature is gearing up for the 2022 Legislative Session with a series of Interim Committee Weeks scheduled through the end of 2021. Legislative committees are meeting in October and November to receive state agency updates, budget requests, and to consider legislation impacting Florida residents.

The legislature meets in session every year for sixty consecutive days. The 2022 Florida Legislative Session begins Jan. 11 and ends March 11.

In 2021, more than 3,100 bills were introduced in the Florida Senate and House of Representatives, with upwards of 2,600 amendments introduced to guide the legislation through various committees prior to a floor vote. During the final days of last year's legislative session, 3,788 votes were taken during 39 floor sessions. Only 275 bills were passed by both chambers and sent to Gov. Ron DeSantis for consideration.

#### **GOLD STAR FAMILY DAY IN FLORIDA**

## Florida Women Veterans Town Hall Meetings

I consider it an honor to be the chairperson of the Florida Department of Veterans Affairs (FDVA) Fact-Finding Committee on Women Veterans Benefits and Communications.

With the backing of the Governor and the FDVA Director MG(r) Hartsell, our committee was established to assess the needs of Women Veterans in Florida, and to bring awareness by communicating State and Federal Veterans' benefits afforded to the 165,000 Women Veterans who call Florida home. The Fact-Finding Committee will conduct a total of 4 Town Hall meetings with women veterans to capture their opinions and any recommendations for improvement. Our committee is an extension of the FDVA's Operation Forward March initiative, and we will build on its findings. Our committee will deliver a written report to Governor DeSantis by Jan 1<sup>st</sup> 2022 with our findings and recommendations to better serve our women veterans.

Our 14-member Committee is comprised of twelve female veterans, many who have served in combat from Vietnam to Afghanistan, and our two female civilian members are active in organizations that support female veterans. Each Town Hall will allow attendance in person and virtually. We held our first of four Town Halls here in Orlando, and we are hosting 3 additional Town Hall meetings on October 7<sup>th</sup> in Jacksonville, October 21<sup>st</sup> in Pensacola, and Oct 28<sup>th</sup> in Ft. Lauderdale. If you are unable to appear in person, we are urging participants to appear virtually.

Our committee is highlighting State and Federal Veterans' benefits to ensure they are accessed by all eligible Veterans, especially our Florida Female Veterans. I encourage you to get the word out on our upcoming Town-Halls, and for women veterans to take a short Florida Women Veteran's Survey <a href="https://www.surveymonkey.com/r/TGSCG5Y">https://www.surveymonkey.com/r/TGSCG5Y</a>.

There is safety in numbers and having 165,000 strong-willed Florida female veterans is a force to be reckoned with! Again, I thank all my sisters in arms for participating, and I appreciate each and every one of you.



## Have you ever wondered why there are two "Navy" days in October?

The Two Navy Holidays: Navy Birthday and Navy Day From Military.com

The Navy Birthday is one of the two Navy-wide dates celebrated annually – Navy Birthday and Navy Day.

The United States Navy was originally established as the Continental navy on 13 October 1775, when the Continental Congress authorized the procurement, fitting out, manning, and dispatch of two armed vessels to cruise in search of munitions ships supplying the British Army in America. The legislation also established a Naval Committee to supervise the work. All together, the Continental Navy numbered some fifty ships over the course of the war, with approximately twenty warships active at its maximum strength.

Navy Day was originally sponsored by the Navy League 1922. Navy Day is designed to give recognition to the naval service. The Navy League of New York proposed that the official observance be on 27 October in honor of President Theodore Roosevelt, who had been born on that day.



In 1972 Chief of Naval Operations (CNO) Admiral Elmo R. Zumwalt authorized recognition of 13 October as the Navy's birthday. In contrast to Navy Day, the Navy Birthday is intended as an internal activity for members of the active forces and reserves, as well as retirees, and dependents. Since 1972 each CNO has encouraged a Navy-wide celebration of this occasion "to enhance a greater appreciation of our Navy heritage, and to provide a positive influence toward pride and professionalism in the naval service."

### Florida Senator Tom Wright is Guest Speaker at MOAACC Lunch

Florida State Senator Tom A. Wright was the guest speaker for the August 17 luncheon of the Military Officers Association of America's Cape Canaveral Chapter (MOAACC). The luncheon was held at The Tides Club, at Patrick Air Force Base.

Senator Wright was elected to the Senate in 2018 and represents Senate District 14, which consists of parts of Brevard and Volusia Counties. He currently serves as Chair of the Senate Committee on Military and Veterans Affairs, Space, and Domestic Security. He also serves on six additional committees: The Committee on Children, Families and Elder Affairs; Commerce and Tourism; Finance & Tax; Transportation; and the Appropriations Subcommittees on Education, and Transportation, Tourism, and Economic Development. He is also proud to serve as Co-Chair of the Florida Space Caucus and the Florida Manufacturing Caucus, and is an appointed member of the Florida Defense Support Task Force.

As Senator, his priorities have included supporting Florida's veteran population, improving the State's water quality, and striving to protect Floridians through consumer protection and prescription drug transparency initiatives. Throughout his personal life, Senator Wright has dedicated his time and effort to assist with affordable housing for the homeless, and to eliminate the domestic abuse of women, children, and animals.

Speaking to a group of mostly retired military officers, he spoke of his family's military history. He is currently helping veterans with PTSD get alternative treatment, which generated a study which will be presented to the VA. Some of his most important work is to ensure that military ranges and spaces surrounding military bases in Florida are not degraded. This includes the over-water ranges required by the Air Force and Space Force. He has also helped pass legislation for law enforcement/first responders' usage of drones, and sponsored legislation to allow medical transportation of K9 dogs injured in the line of duty.



The Veterans In The Classroom (VITC) program needs Veterans to give presentations about their military service to Citrus County school children between Nov 1<sup>st</sup> and November 10<sup>th</sup> of this year. The VITC program has been in place for over 20 years. Since the VITC's inception, the Citrus County school district has been a strong advocate for the program. The VITC is one of the many events of Veterans Appreciation Week honoring our county's Veterans.

The VITC program is managed by the Military Officers Association of America (MOAA) Citrus County chapter. COL Mark Bodenheim, USA (Ret), himself a 39 year veteran, is the current VITC program manager. He states, "Since 2019, we have lost over 20% of our Veteran presenters due to illness, death or moving out of the county. In a county with nearly 20,000 Veterans, we should have a lot more than the 60 Veterans on our current contact list. We need to get the message out there that we need Veterans to step up to this mission."

COL Bodenheim started digitizing the process of matching Veteran and teacher requests. All Veterans who want to be presenters, even if they presented in in the past, will need to register online for the VITC program. When registering, a description of the VITC program appears, along with photos of presenters in previous years. In the registration process, Veterans will be asked to give a brief description of their military acquired skills. COL Bodenheim states, "I have teachers requesting cooks, band players, helicopter pilots, accountants or foreign language speaking Veterans. The digital registration process will permit me to match more closely the Veteran's skills to a teacher request."
