Help MOAA Fix the TRICARE Young Adult Coverage Gap

MOAA continues efforts to build support for **The Health Care Fairness for Military Families Act of 2021 (H.R. 475)**, introduced by Reps. Elaine Luria (D-Va.) and **Michael Waltz (R-Fla.)**. This bipartisan bill would expand TRICARE eligibility to young adult dependents up to age 26, bringing TRICARE in line with commercial plan requirements.

The bill is gaining momentum, picking up eight co-sponsors since its February introduction – *disappointingly, there are **NO** co-sponsors from Florida!* MOAA’s goal is to advance the legislation to the FY 2022 National Defense Authorization Act (NDAA) to ensure children from military families transitioning to adulthood have the same health care protections as those afforded to their peers in civilian families.

The TRICARE young adult parity issue will be one of three topics championed by MOAA members during our upcoming Advocacy in Action campaign. This issue was reported on in the February Communiqué.

The Military Coalition (TMC), a group of military and veterans service organizations representing a combined 5.5 million-plus membership (MOAA serves as a co-chair), has added its support with a letter endorsing H.R. 475 and thanking Reps. Luria and Waltz for their leadership on this issue.

COLA Concerns: Could 'Chained CPI' Make a Comeback as Budget Pressures Mount?

If you're familiar with [MOAA's COLA Watch](#), you know that military retirement, Social Security, and other benefits are indexed to a variant of the Consumer Price Index (CPI), which measures the cost of a variety of goods and services. Adjusting how this index works could cost retirees and others receiving benefits a significant amount of the income they've earned and rely upon.

A CBO report lays out the case for doing just that, suggesting an expansion in the use of "chained CPI" in these calculations. Chained CPI calculates user spending patterns differently than the traditional model and – not surprisingly, given the goal of the CBO report – traditionally results in a lower growth rate leading to smaller COLA increases. One chained CPI variant tracked about 0.25 percentage points below the traditional calculation each year since 2001, [per the report](#).

MOAA has taken action on previous chained-CPI recommendations, calling them out for what they are: A benefit cut that unfairly targets many members of the uniformed services community, particularly retirees and disabled veterans. These individuals access inflation-adjusted benefits at an earlier age than most, meaning any reductions in their benefit would have a longer lasting, more devastating effect on their bottom line.

The Chained CPI is just one of several budget-cutting options in a CBO Report that could cost you thousands of dollars. Thirteen specific Military related "options" are explained by Dan Merry, MOAA V.P. for Government Relations, in his December 17, 2020 Advocacy News column [Read Report Summary Here](#)

MOAA will work to ensure elected officials understand the wider impact of proposals such as using chained CPI, especially as it applies to the benefits earned by MOAA members and others through their service. ***MOAA members can stay engaged with these and other advocacy issues by visiting MOAA's [advocacy news page](#); should any proposals advance beyond the CBO-report stages, we will be ready to mobilize any necessary resources.***

TMC Letter to SECDEF Warns Against TRICARE Fee Hikes, Medical Billet Cuts

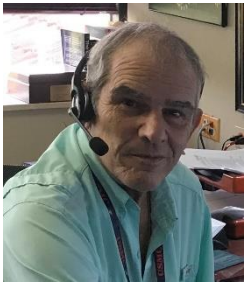

The Military Coalition (TMC), representing a combined 5.5 million-plus membership, urged DoD leadership in a March 8 letter ***to protect the military health system*** from proposals that threaten the health care benefit, medical readiness, and the pipeline of uniformed health care providers.

The letter, sent to Secretary of Defense Lloyd Austin, addressed three topics DoD leaders will consider as they undertake the FY 2022 administration budget request:

- medical billet cuts,
- funding for the Uniformed Services University of Health Sciences (USU), and,
- the potential for TRICARE fee increases as a means of reducing military health system (MHS) spending.

Local National Cemeteries

A lot of readers of the Communiqué want to be buried or interred at Arlington. Having been to a burial there, it is truly a moving experience.

But... not everyone does. It can take up to six months to schedule and execute the event, and it's all the way up in DC. Getting a casket plus all friends and family up there can be challenging and is obviously expensive.

At the same time, there are nine National cemeteries in Florida and the arrangement can be set up just about immediately. National Cemeteries are found from Barrancas National Cemetery in Pensacola to Jacksonville National Cemetery to South Florida National Cemetery in Lake Worth, with six other places in between.

Here's the important part: Statistically, odds are very high that the non-military spouse will be doing the arrangements for the military spouse. Let's try to reduce the stress in an obviously stressful time. Start by *right now*, put a copy of your DD-214 in a very accessible place. Make multiple photocopies and put them in logical places where an *unknowing* person would look. Give a copy to a responsible child or a good friend.

Assuming this is being done *without* pre-need arrangements having been done, and you do not desire or are not eligible for Arlington, when the time comes, your spouse (or whoever will be handling the details) should start as follows:

1. Fax the DD-214 to the VA at 866-900-6417 or email it to NCA.scheduling@va.gov. (Personal opinion: fax it if possible. Email is totally unsecure. UPS Stores will fax it for less than ten dollars.) If you don't have a DD-214, the VA accepts numerous other documents as proof of service. See the VA cemetery website for the complete list. I would include basic information on the cover sheet such as your contact data with the DD-214 plus a statement to the effect that "Colonel John Benotz passed away on March 20, 2021. We will be requesting internment in a National cemetery.
2. Download the cemetery checklist from cem.va.gov. This checklist includes all the questions the scheduler will ask. It includes things such as SSN, service, rank, and desired cemetery. Fax the DD-214 and fill out the checklist before calling them.
3. Call the VA Scheduling Office at 800-535-1117. This can be done by a family member or a funeral director. The scheduling office is open seven days a week from 8am to 730pm east coast time. (I called this number while writing this article. Have something else to do while you are on hold for 30-40 minutes is a good idea...)
4. Internments are done Monday through Friday.
5. If you and your family desire "military honors," the funeral director will request it. DOD requires at least forty eight hours' notice for providing a burial detail. The detail will include two service people in uniform, at least one of which will be from the veteran's service. The detail will fold the flag and present it to the family.

I've been to National Cemetery interments that were done by VA employees and others done with military honors. Both were done very professionally. It's not Arlington, but it's done very nicely.

Keep in mind that the DOD will do just one ceremony per veteran. I've seen a few situations where the family was going to move the veteran to Arlington but also do a funeral in Florida. DOD will *not* do a ceremony in both places. The family was rather disappointed to hear that they could not also have one in Florida before going to Arlington. Also, the one ceremony means one ceremony. You can have it at the funeral service or the graveside, but not both.

The VA allows, and actually encourages, participation by veterans groups. This means, of course, members of your local MOAA chapter may participate in a ceremony.

Incidentally, if you make pre-need arrangements with a funeral director beforehand, you can submit the necessary paperwork and get a "pre-need decision letter" beforehand. This will simplify the process when the time comes to make it happen. It's not a reservation in a specific cemetery but it is proof that you rate burial in a national cemetery.

As mentioned above, I called the scheduler number and talked to a human. He said that it's okay to give something to any veteran's group people that participate in the ceremony, but nothing should be given to the service people in uniform. Ummmmm. I was the commanding officer of a Marine Corps Reserve unit that provided Marines for lots of burials. Though the Marines were paid by the government to participate in the ceremony, it rarely covered the cost of them taking off from their civilian job, driving to the funeral, and prepping and cleaning their dress blues. I would recommend that you very discreetly give the participants a tip for their efforts. They will definitely appreciate it.



Surviving Spouse Corner

As you know after more than 15 years of lobbying, MOAA finally persuaded Congress to eliminate the SBP/DIC offset. Last year this process began, and it is phased in over three years. Starting January 1, 2023 the offset will be eliminated. Recently, I have had quite a few queries about this. There is still some confusion. While reading the Army ECHOES this month, I came across a simple succinct explanation of these changes. The explanation was penned by Patty Cruz, Army Survivor Benefit Plan Program Manager. I summarized the information below.

If you are a surviving spouse eligible for both SBP and DIC, you will always get paid the full DIC amount from the VA. The SBP annuity amount however, is offset or reduced by the DIC amount. If the SBP annuity amount is greater than the DIC amount, then you will receive the difference from DFAS plus the Special Survivor Indemnity Allowance (SSIA). DFAS pays out SSIA to survivors who have their SBP annuity offset by DIC. If your SBP annuity amount is less than the DIC amount, then you will only receive the SSIA from DFAS. The new law reduces the amount deducted from your SBP annuity, so depending on the SBP annuity you are eligible for, you may start seeing more of your SBP annuity starting this year. Some surviving spouses will not see an increase until 2022 or even 2023 when the offset is totally eliminated.

The Defense Finance and Accounting Service (DFAS) sent out letters in December 2020 to each surviving spouse affected by this change in law. Your letter will outline your specifics.

Remember that your situation is unique. Percentages of SBP payouts are different. Percentages of Disabilities are different. And there is the issue of whether the service-related disability was a contributor to death. Comparing amounts to other Surviving spouses will only lead to confusion. Your DFAS letter is your guide.

To summarize:

DIC benefit will continue to be funded by the VA in the full amount.
SBP offset will decrease to 2/3 DIC in 2021; 1/3 of DIC in 2022; full amount (no offset) in 2023.
SSIA may be received in 2021 and 2022. No SSIA will be received in 2023 because the SBP/DIC offset will have been eliminated.

Advocacy In Action - A Head Start:

On Thursday 1 April 2021, Congressman John Rutherford addressed an assembly of about 60 Chapter members and Fleet Landing residents at a town hall in our newly renovated Johnson Hall onboard Fleet Landing.

The Congressman opened with some personal background of growing up in a Navy family, traveling all over and finally settling in Jacksonville, and becoming the local Sheriff as well as some personal empathy with two of MOAA's topics for 2021 Advocacy In Action (AIA) ; Toxic Exposure of service members and Food Insecurity for junior enlisted military families.

After about 20 minutes of opening remarks the Congressman took questions from the audience in a lively exchange for about one hour. During those dialogues he stressed a bi-partisan approach as the best chance for success to pass good legislation and gave the crowd hope that bi-partisanship does exist in the 117th Congress. He stressed that the name on bills means nothing; it is what is inside the bill that matters and his team does that research for him. He explained why he voted for or is voting against several bills in process because of what they contain regardless of how noble they sound in name.

I will be contacting Congressman Rutherford again during the AIA event and I believe he will be a supporter if not a champion for at least two of our MOAA 2021 AIA topics.

MOAA Foundation: Feeding Active Duty Military Families

On Tuesday 30 March 2021, a group of nine volunteers from MOAA's Historic Mayport Chapter and Fleet Landing assembled with USO Mayport staff out at a local Jersey Mike's Sub Shop to distribute meals to active duty enlisted military service members and their families. Our volunteers helped to set up tents and tables and received instruction on procedures to follow for this No-Dough-Dinner (NDD) To-Go event.

Families had pre-registered with USO Mayport for 218 meals. Our Chapter used the last of our MOAA Foundation 2020-2021 Community Outreach Grant to fund this event through USO Mayport.

Families began arriving promptly at 3:00 PM. ID cards were checked, the number of persons in the family was verified, and box meals were delivered to each vehicle by the team. Each meal was a box with a turkey sub sandwich, a bag of chips and a brownie

Families who have an urgent need for support are identified by local base Chaplains and Command Master Chiefs and are given priority.

Historic Mayport Chapter helped serve 153 meals between 3:00 and 5:00 PM when additional USO Mayport staff arrived to complete the event lasting until 6:00 PM.

Our volunteers felt great about supporting our military families and all the families were very grateful for the Jersey Mike's meals. Thanks to our volunteers, to USO Mayport Director Joyce Shellhorn and her staff and to the owners of Jersey Mike's for their support!

Helping Veterans at No Cost

Our first in-person monthly meeting of MOAA's Historic Mayport Chapter took place yesterday (25 March 2021) in the newly renovated Johnson Hall onboard Fleet Landing.

Leaders from the National Association of Families and Veterans (NAVF) located in Green Cove Springs visited Fleet Landing to provide an update on veteran's benefits and rules / procedures for dealing with the Veterans Administration (VA). NAVF had last visited Fleet Landing on 23 January 2019. Returning were Joe Solsona and Jeff Faulkner accompanied this time by Craig Ames. Joe and Jeff are VA-certified Veteran Service Organization (VSO) case workers and Craig is a VA-certified legal representative. Being VA-certified means these gentlemen are legally able to advise veterans on their rights and benefits and assist veterans with claims and appeals.

Joe's bottom line was that 73% of all claims filed with the VA are denied, compared to a 99% success rate for NAVF-filed claims and appeals based on handling 50,000 submissions. Joe's message was that veterans should seek the assistance of a not-for-profit VSO that does not charge veterans for their services, such as NAVF, to help veterans prepare and submit claims and appeals to the VA.

Additionally Joe covered scams and ways to protect seniors from a variety of threats, the need for estate documents and reasons to update those documents, and the need and strategies for end-of-life planning.

Attendees were very appreciative of the information provided and the knowledge that the resources of NAVF were available to them when needed.

MOAA's Historic Mayport Chapter was happy to be invited by Senior Military Instructor Major Trent Johnson, USAF (Ret) to the first awards ceremony in 2021 of the eight JROTC units our Chapter supports. The "Flying Tigers" of Andrew Jackson High School were in high spirits after a year of missing in-person events due to COVID-19. The Jackson "Flying Tigers" are unique in that they are designated a "Flight Academy" offering a flight instruction program for cadets.

He stated that crime in the area has been reduced by 20% but that car burglaries have increased. Most of the car burglaries have been attributed to 15 or 16 yr. old youths and primarily take place on unlocked cars.

The HCSO was kept busy during the Super Bowl and he noted that the boat ramps, because they are one of the few activities people could enjoy during the pandemic, were also crowded.

Deputy Jeff Merry also attended the meeting and discussed scams. The two most prevalent scams are those involving Amazon (advising people that they have ordered an expensive item and if not they should call a bogus number) and car warranties being expired. Jeff also recommended that people tune in online to a play entitled Phony Baloney. It can be seen live on Facebook on Saturday, March 13th at 2:00 PM. For additional information on the play Jim Haney can be contacted at jhaney1@gmail.com. Col. Ura emphasized that no government entity calls and asks for money.

Col. Ura also discussed Project Safe Encounter, which deals with mental health management, primarily for homeless and/or missing family members.

Two road 'Alerts' were also discussed.

The Silver Alert --- for lost or missing seniors and the Amber Alert --- for missing or abducted children.

The local chapter of MOAA, a 501 (c) (19) organization meets at 11:00 monthly in the Florida Room at the CA Atrium (when there is no pandemic). A luncheon and speaker are featured.

MILITARY OFFICERS ASSOCIATION MEMBERS GET A COVID-19 UPDATE FROM PAUL GROVE, WEDU PBS PRESIDENT AND CEO

Despite COVID-19 concerns, 31 MOAS members and guests enjoyed lunch at Michael's on East and heard an update on our local public television station, WEDU PBS, delivered by WEDU President and CEO, Paul Grove. Mr. Grove served as WEDU's VP for national programming before heading to Chattanooga in 2006 to head up their local PBS station, WTCL.

Returning to WEDU as President and CEO in 2019, Paul found a shift in emphasis at WEDU; less on developing national programs, more towards local programs. He has continued this focus, with a vision that encompasses Community, Innovation, and Education. WEDU provides services to 16 counties in West Central Florida through its six operating channels – WEDU, WEDU World, The Florida Channel, WEDQ, PBS Kids, and WEDU Create TV – and has been working hard during the pandemic to support education and distance learning, as well as public safety and civic leadership.

Paul noted that WEDU just completed a five-part series about non-profits and the art world in Sarasota. A future project will cover Sarasota's business world. Paul noted that for 18 straight years Americans have ranked PBS and its member stations the most-trusted institution among a consideration set that includes courts of law, commercial cable and broadcast TV, newspapers, and streaming services. Americans also rank PBS highly in terms of value for tax dollars. Viewership is up, both over-the-air and on cable. During the pandemic, WEDU has provided an essential service for so many families unable to access media otherwise.

In the big picture, the goal of PBS educational services is to prepare children for success in school and in life. When the COVID-19 pandemic brought about the need for distance learning, PBS, as a national leader in digital education, was well-positioned to help with the transition into e-learning formats. WEDU created the WEDU PBS At Home Learning webpage featuring an array of resources for families and educators and helped address the needs of families who may have technology challenges by providing daily broadcasts of PBS programming along with companion lesson plans for distance learning.

We were fortunate to be proceeding with the event this year, and our April 7, 2021 event was renamed "The MacKenzie-Janes Tribute Golf Outing" to honor Alex MacKenzie (at right) who retired after 26 years as our Treasurer in December. We are excited that our 36 foursomes were filled and we had 60 hole-sponsors. We are acknowledging our oldest golfer, 1LT Bill Reiff, age 97 – who has an amazing 14 handicap. Drafted at age 19, he became a P-51 Mustang pilot and flew cover missions over the Battle of Normandy on D-Day. Bill was honorably discharged at the end of the war with a Distinguished

Flying Cross as well as 8 Air Medals for acts of heroism and meritorious achievement. He is now helping our mission of raising funds to serve Lee County veterans, their families and our 16 High School JROTC units.

We are proud of the fact that our Chapter brought the blueprint for Mission United 211 to our local United Way and continue to serve as a stakeholder on the board, donating \$5000 annually to the program. They fielded 80,545 calls and helped 1790 veterans in 2020 alone. In the last four years we have established a veteran’s scholarship at FGCU, a disabled Veterans Scholarship at FSW, and given \$18,000 in scholarships to graduating JROTC seniors enrolled in ROTC pursuing a military career. We have also spent \$7600 sponsoring the annual county-wide JROTC Raider Challenge competition.

Lee Coast MOAA funded an outdoor gathering and eating area at Heart & Homes for Veterans; and are planning to pay for repairs on a bus donated to transport veterans to the facility and VA appointments, as soon as Covid19 regulations allow it. Several of our members who have helped with food and home goods donations and distribution will be volunteering in a new classroom (if our MOAA grant request is approved) for staff and veterans. We will be helping veterans write resumes, research employment opportunities, etc. as part of their transition out of homelessness and breaking the downward cycle that landed them there. Our efforts will be led by their Operations Manager, who is one of our new members, and one of our Foundation Board members who recently joined the Hearts & Homes Board, helping them as part of her Master’s Degree program.

In addition to the above, we have distributed specialized mp3 players “Songs & Stories for Veterans”, purchased food for the “Feed our Vets” VA program, fed meals to veterans at the Military Museum and Spirit of ’45 and purchased yarn for knitters to make lap robes etc. for veterans. We have raised and contributed just under \$100,000 these past four years, in our “Never Stop Serving” endeavors, and hope to net another \$25,000 for continuing our work this year.

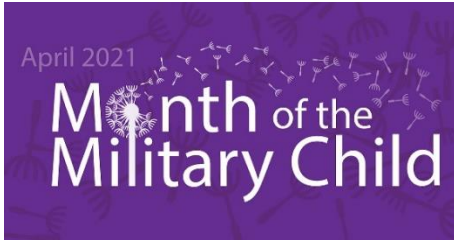

WAYS TO CELEBRATE

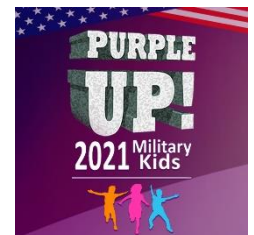
Wear purple on Purple Up Day - Wearing purple is a visible way for everyone to show support and thank military youth for their strength and sacrifices.

Subsequently, the Department of Defense standardized the date by declaring the Friday before Mother's Day every year as "Military Spouse Appreciation Day" to show appreciation for the sacrifices of military spouses.

There is another group which deserves special thanks—the wives of our servicemen, wives who take care of the families and raise the children while their husbands are at sea or stationed far away, and wives who have left our shores to be in a faraway land with their husbands... Their contribution is critical... The understanding and encouragement they give our servicemen is something we must all be grateful for. President Ronald Reagan.
