April is here and it feels like summer outside--That also means we are gearing up for MOAA’s signature legislative push, “Advocacy in Action,” and we are in final preparation for our annual Florida-wide Convention next month! Meanwhile, our Membership Campaign is in full swing to attract new members into our chapters.

First, on the Membership Campaign--Over the past several months we have worked with MOAA National to encourage the over 30,000 non-chapter MOAA members in Florida to join a chapter. On April 5th, MOAA President and CEO Lt Gen “BK” Kelly (USAF-Ret), sent an email to those MOAA members residing in Florida who are not chapter members, encouraging them to join a local chapter. The email also informs them how to find the nearest chapter and invites them to our May convention. Our goal with this push is to let those non-chapter MOAA members know what we do and get them to join a chapter. The next step in the campaign is for chapters to send an invitation email (from MOAA) to non-chapter MOAA members in their area and invite them to a chapter luncheon, dinner, Officers Call, or other event, and to join. Instructions for requesting the MOAA email went out to Area Vice Presidents and Chapter Presidents earlier this month. Let’s keep up the momentum to build stronger chapters and raise our numbers--Let me know if you have any questions!

In concert with MOAA, our Florida Advocacy in Action campaign is underway! The council has plans to meet with all the Florida Congressional Delegation or their staffers on Capitol Hill on April 26th. All our Chapters and members are key to this effort, and we need your support to send in the pre-printed letters from MOAA’s *Military Officer Magazine* and TAKE ACTION through MOAA’s Legislative Action Center to convey your support. Our legislative team has more information on how chapters and members help. Let’s make sure our voice is heard on Capitol Hill—loudly!

The annual Convention is right around the corner and is shaping up to be a momentous event! Hosted by the Ancient City Chapter, it is at the Renaissance Hotel in the World Golf Village in St. Augustine from May 19th-21st. 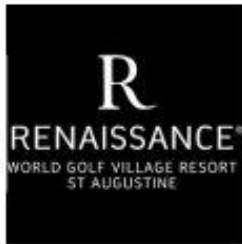

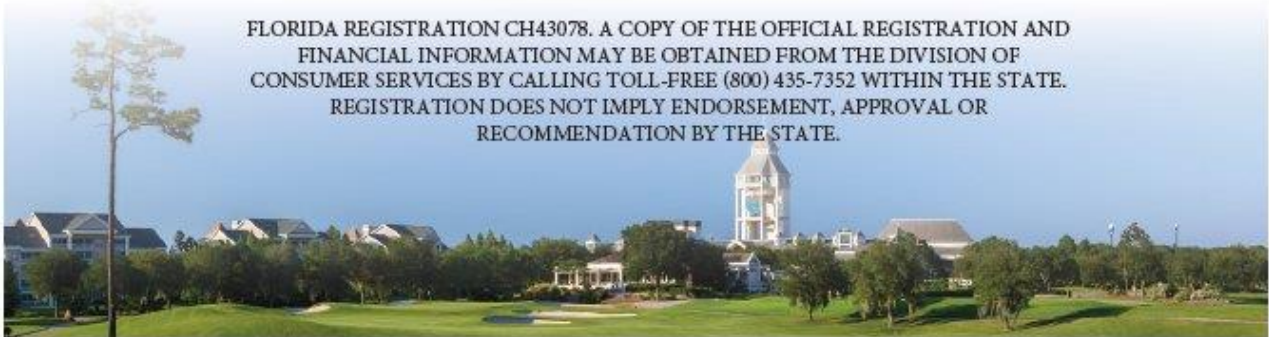

Zelle

Five years ago, I needed a kidney transplant. Through Facebook, I found a donor - a young Marine in California. We were discussing the logistics of getting him from the west coast to Florida.

He said, "I don't have any money." I responded that he need not worry. I'd cover all of his expenses. I offered to overnight him a check. He said "Better idea. Send it by Zelle."

Zelle? What's that?

Kids use it all the time. It's a bank-to-bank transfer. Most banks offer it. I checked my bank's app. One of the tabs said "Zelle." I clicked on it, put in my donor's cell phone number, and saw his name. I filled in "\$5" and put in the comment block "let me know when you get this." I hit "send."

Thirty seconds later, I received a text from him. "Got \$5." I sent him the full amount. He flew to Florida. I get my kidney.

Zelle is super simple, very quick, and free. If you don't believe me, click on Zelle on your bank's app. Put in a grandchild's cell number, and send \$5.

Why do I mention this? Aside from the fact that it's extremely convenient, your Chapter can use it to collect money for events.

Unless your chapter only has a phone number, you can use an email address. The Palm Beach - Martin Counties Chapter happens to have one. Our treasurer went into the bank and connected "moaapalmbeach@gmail.com" with our checking account.

Now, when a member signs up for an event, some members mail checks. A growing number open their bank's app, click on Zelle, put in "moaapalmbeach@gmail.com," enter the dollar amount, and hit send.

They get an email from their bank stating that it went, and the chapter gets an email saying that the member sent however many dollars they sent.


It's instant and free. No longer does PayPal take a noticeable portion.

Why do banks do this? I don't know for a fact, but I'm sure that it's much less expensive to transfer money by Zelle than by handling a check. Think about it. A Zelle transfer requires no human activity. You can't really say that about a paper check.

The Zelle website says that over 1,600 banks participate in Zelle. I checked a bunch of the common bank names in Florida and they all participate. Just log onto your bank's mobile app, look for "Zelle" or maybe "transfer money," and give it a go.

And if you're involved with the finances of your chapter, consider using it. It really is simple and efficient.

Give it a try. You may not end up with a kidney transplant, but your grandkids will love it!

Tax Time Considerations

If you have already filed your 2022 taxes, BRAVO!

Some have not. Some are procrastinating. Others may be receiving documents through mid-March depending on investments held or have just received amended or corrected documents and are just beginning the process.

Please file by the due date, if at all possible. You may file an automatic extension, but taxes are due on the April date. If you extend, don't wait to file on October due date, file as quickly as you can. A relocation, an illness, or a family death, could happen to you or your preparer (consultant) in that time frame, and create more complications.

2023 tax considerations for those widowed in 2022

If your spouse died in 2022, you can still file 2022 taxes as married as long as you have not remarried in 2022.

Next year, 2023, you must file as single if you have not remarried or have no dependents. This can cause tax consequences you should consider and prepare for. See the charts below. (Information was taken from the IRS publications Form 1040, and instructions for Form 1040.)

1040 STANDARD DEDUCTIONS	single	married
	2022	\$12,950 \$25,900
	If over 65, an additional	\$ 1,750 \$ 3,500

1040 TAX TABLE 2022 (examples)	single	married
Income \$50K	tax due \$ 6,623	\$ 5,592
Income \$100K	tax due \$17,830	\$13,229

As your deduction goes down, the tax rate goes up. This disparity grows as income grows. See below.

1040 TAX RATES 2022 for income exceeding \$100K

Single	%	married	%
\$100,001 to 170,050	24%	\$100,000 to 178,150	22%
	Jumps to higher %	\$178,150 to 340,000	24%
\$170,050 to 215,950	32%	\$340,000 to 431,900	32%

These tables demonstrate that a lower single income is taxed at a higher rate than married income.

If your spouse was the higher income earner, there will be a change in tax owed, but it may be a manageable increase or it could be less. If you are the higher income earner, you will have a lower standard deduction and you may pay taxes at a higher rate.

Investigate these changes or discuss them with your tax preparer. Be prepared. If you need to convert an investment to cash, be aware of the tax consequences.

Possibly your spouse always did the tax filings and this is new to you. If you are overwhelmed, get help. If a mistake is made or some income or deduction is overlooked, you can always file an amended return. Give it your best effort and try to file by April 18, 2023 and prepare for the 2023 changes.

One more thing....

If you missed the last SS Virtual Chapter meeting when Lt Gen Kelly addressed our group, and there was a discussion of Advocacy in Action, contact me through the website. The meeting was recorded and I can send you a link and passcode.

If you are not yet a member, go to the MOAA website. Search for the Surviving Spouse Virtual Council fill out the membership application and return it according to the instructions. If that does not work for you, print the application, fill it out and scan or photograph the form and send it to me deg06@aol.com.

Also, be sure to sign and send in the blue letters (included in the MOAA Magazine) to our Majority and Minority Congressional Leaders. Send your own letters to them, as well as to your Florida Congressmen and Senators. Participate in preserving military benefits earned.

What's Behind Curtain Number Three?

Elsewhere in this newsletter you will have read about the **TWO Primary** goals for this year's Advocacy-in-Action Campaign when we will be asking members of Congress to

- ensure that our servicemembers get 100% of their Housing Allowance by supporting **BAH Restoration**;
- ensure language in the FY 2024 National Defense Authorization Act (NDAA) directs an analysis of access data to assess the impacts of **Pharmacy Network Cuts** and thus expand the network participants.

Both of those two goals are key components of the compensation and benefits package that sustains the all-volunteer force and are essential to addressing what's behind the proverbial third curtain:

Combating the growing crises facing the recruitment and retention of the all-volunteer force.

Since the end of the military draft in 1973, the AVF has protected our nation at home and abroad. But now, DoD finds itself in a war for talent:

- The services are struggling to recruit and retain the force we need to defend our country and support our allies when called upon.
- The active component faces an environment where personnel shortages result in increased workloads and reduced quality of life amidst a recruiting crisis.
- The National Guard is worried about rebounding from the stresses of the COVID-19 pandemic and its largest mobilization since World War II.

Lawmakers must no longer ignore the decreased interest in – and eligibility for – military service.

- only 63% of servicemembers, retirees, military families, and veterans would recommend military life to someone,
- 77% of young Americans would not qualify for military service without a waiver due to being overweight, drug use, or having mental or physical health problems.
- only 9% of young people who do meet the eligibility criteria are interested in military service.



Reversing these worrying trends requires a whole-of-government approach, and Congress must use all the tools at its disposal to keep the AVF ready and capable.

- To ensure the future of the force, the current force and the pool of veterans and retirees who previously served must both be taken care of to ensure they exert a positive influence to serve for the next generation of potential recruits.
- The treatment of and perspectives of influencers across all aspects of their experience, both during and after they served, is often more impactful and important to recruiting than the actual marketing messages or efforts by recruiters.

Deliberate steps such as improving physical fitness and health programs in our education system, will help increase the pool of eligibles over time.

Investing in uniformed community housing, health care, child care, food insecurity prevention, and improved facilities and services will make a meaningful difference to those already in service.

We must ensure military pay and benefits stack up so that recruiters have a chance in building up today's All Volunteer Force.

Support Expanding Arlington National Cemetery with Second Location and Full Burial Benefits

The years long campaign to preserve the burial eligibility for military retirees in Arlington National Cemetery continues.

ANC will not reach capacity with current eligibility standards for another 42 years and a long-term solution to protect the equivalent level of benefits is warranted.

Here are the FACTS

- ANC will eventually run out of room.
- An enduring solution is required to maintain an equivalent level of benefits.
- The VA runs 155 national cemeteries and the DoD runs ANC.
- While DoD's primary focus for resources is national security, partnering with VA will provide an integrative approach with resources.
- Transforming a VA national cemetery to afford full military honors would sustain an equivalent of benefits at an existing facility.
- Cooperation between DoD and VA can offer a solution in which VA runs operations, and the armed services provide ceremonial honors at the same level as ANC.

Florida has the second largest number of military retirees – 210,073. We need to rally the troops to protect the benefit of in-ground burial with full military honors for those who plan for internment or inurnment at a DoD managed National Cemetery.

Florida Department of Veterans Affairs Update

Governor's Framework for Freedom Budget Strongly Supports Florida's Veteran Community

TALLAHASSEE – Gov. Ron DeSantis' Framework for Freedom Budget provides timely and essential services and support to the state's 1.5 million Veterans, their families and survivors through the Florida Department of Veterans' Affairs (FDVA).

FDVA is a constitutionally chartered State Veterans' Affairs department responsible for serving the Nation's third largest Veteran population. Operating as the premier point of entry for Florida's 1.5 million Veterans, FDVA operates a network of nine State Veterans' Homes and provides statewide outreach to connect Veterans with their earned services, benefits and support.

Florida Department of Veterans' Affairs Executive Director James S. "Hammer" Hartsell said: "As a Navy Veteran, Governor DeSantis is a true patriot who appreciates and understands our Veterans' community. Since 2019, he and his administration have committed hundreds of millions of dollars to our department, helping to ensure a positive future for our nation's heroes and their families. Because of his leadership and administration's collaborative focus on enhanced Veterans' Advocacy, Florida is the most Veteran sought-after and Veteran-friendly state in the nation."

Included in this year's budget recommendation is an increase in the number of Veterans' Claims Examiners in Florida, reflecting an expanding population influx, the state's large Veteran population and projected growth of U.S. Department of Veterans Affairs health care facilities. In 2022, FDVA Veterans' Claims Examiners operating out of VA health care facilities assisted more than 272,000 veterans in providing information and counsel on earned services, benefits and support. In addition, claims examiners have processed nearly 35,000 new claims on behalf of Florida Veterans, and helped recover more than \$194 million in retroactive benefits for Florida Veterans and their families.

In addition, one of the biggest responsibilities within FDVA is its network of State Veterans' Homes. The State of Florida boasts eight State Veterans' Nursing Homes and one State Veterans' Domiciliary, including two newly opened homes in Port St. Lucie and Orlando.

Governor DeSantis has proposed funding for capital improvements and replacement of medical and resident support equipment in the state's veterans' homes. Other veterans' home funding includes additional funding to complete the staffing needs for the two new veterans' homes, an electronic time system and support to ensure all of the homes are able to maintain necessary operations.

The Governor's Framework for Freedom Budget continues funding for Florida is for Veterans, Inc. (Veterans Florida), and the Veterans Employment and Training Services program (VETS). Veterans Florida is a non-profit created by the State of Florida to help military Veterans transition to civilian life with rewarding career opportunities and entrepreneurship training. Veterans Florida also promotes our status as the nation's most veteran-friendly state and administers the Florida SkillBridge initiative, which connects active-duty service members with Florida-based jobs in the six months prior to discharge.

The 60-day Florida Legislative Session is well underway. One of the key Veteran-related pieces of legislation, known as "Veterans' Services and Recognition, is moving through the House and Senate. The two bills, HB 485 and SB 824, create a Division of Long-Term Care within the Florida Department of Veterans' Affairs, expand the eligibility of Florida Veterans to become County Veteran Service Officers, and create the "Veterans' Adult Day Health Care of Florida Act" to provide additional services to eligible Veterans in the future. We've all heard the term "military brat" before. It pertains to those children who grew up in military families. "Brats" wear the name like a badge of honor, often because of the moves, stressors and cultural experiences that make them more resilient than their civilian counterparts. But outside of the military, the word brat is often considered derogative. So it made me wonder -- where did the term "military brat" originate?

To find out, I reached out to the folks at National Defense University Libraries, who did some research for me. It turns out the origin of the term is still pretty unclear, but there are a lot of interesting theories behind it, and most of them originate in Britain.

BRAT could be an acronym for British Regiment Attached Traveler

I first found this theory published in a 2011 blog by retired Air Force Lt. Gen. Michael M. Dunn, who was the president of the Air Force Association at the time. Dunn, who had also been the president of NDU, had asked a researcher to find the origin of the term.

One came through, discovering a book published in 1921 that attributed the saying to the British army. It explained "BRAT" as a status standing for British Regiment Attached Traveler, and it was assigned to families who were able to travel abroad with a soldier. Eventually, it just referred to military children. But the term stuck, and was adopted in many places around the world, including in the U.S. While the researchers I spoke to at NDU couldn't find that particular citation that Dunn mentioned, it's a pretty interesting story. And other published researchers have also traced the acronym to the phrase British Regiment Attached Traveler.

Earliest References Were From the 18th Century

Dr. Grace Clifton, a professor at Open University in the UK, has done research with the U.S. Army's Dr. Becky Powell into the origins of the term. Clifton found reference to a song written in 1707 for a satirical play called "The Recruiting Officer" that described soldier life and that of their dependents. Back then, married soldiers were divided into two categories: the lucky few who were allowed to have their families live in the barracks and be taken care of by regimental funds, and those whose families had to live outside the barracks. The song referenced the latter as being "brats and wives." The lyrics may have been the first reference to brat in relation to military families. But it also may have referred to any children. So, that's still a bit of a mystery.

A Contraction for 'Barrack Rat?'

Clifton said the term "barrack rat" was also used at the end of the 18th century in the U.K. when discussing stories about the lives of children in army barracks, so it's possible that the two words were turned into a contraction to create the term brat.

"Barrack rat" also surfaced in "A Dictionary of Slang and Unconventional English." It cited the book "Old Soldier Sahib" written in 1936 by Frank Richards, a British soldier who detailed his experiences while stationed in India and Burma during the early 20th century. In that book, Richards said "children born in barracks were referred to as 'barrack-rats.' It was a wonder to me how the poor kids survived the heat, and they were washed-out little things."

Still No Clear-Cut Answer

Trent University's Dr. Jennine Hurl-Eamon has also researched childhood during the wars of the 18th century. "I must confess that I have come across no archival or early print material as yet that offers a clear indication of how the term 'brat' emerged," she said.

Many modern day military brats will tell you that B.R.A.T. stands for **Born Resilient And Tough** and others might tell you it stands for **Being Relocated All the Time**.

The fascinating, almost unbelievable secret life of Howard Hughes

Following four years of research, Musick finally believed her story and has written two books on the subject.

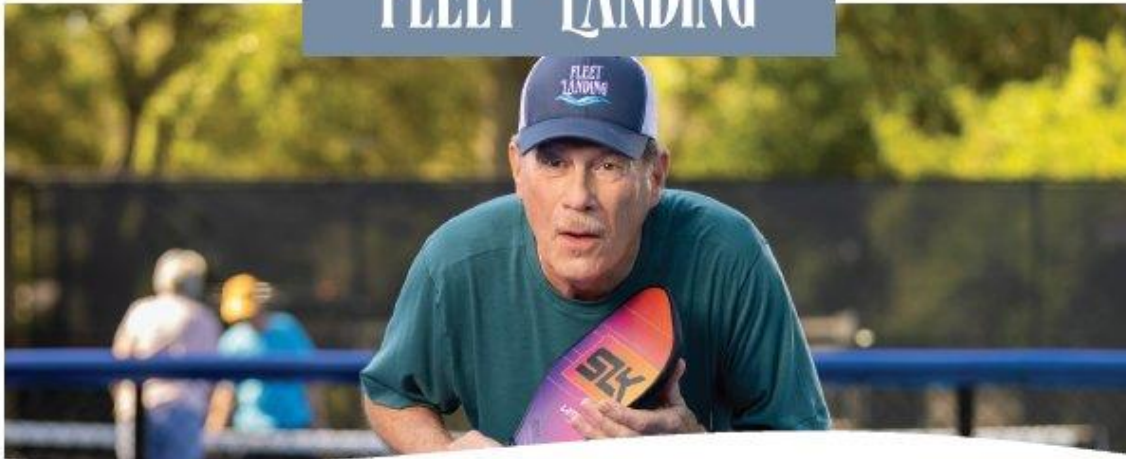
