## Legislative Update February 2021

As we await the new administration's proposals affecting the military community and the legislature's actions with regard to them, this month's Legislative Update takes a look at recent news that informs the tenor for our 2021 advocacy mission.

### MOAA Advances its Goals with the New Administration.

Subsequent to their election and in advance of the inauguration MOAA met with the transition teams of then-President-Elect Joe Biden and then-Vice President-Elect Kamala Harris. Based on those meetings it is clear that the new administration is keenly interested in doing all it can to help improve the quality of life and protect service-earned benefits for all our uniformed service members and veterans, their families, retirees, caregivers, and survivors.

On January 20th, MOAA sent letter to the president asking for swift action in many areas. In it, MOAA urges the incoming administration to consider taking up several issues and working with military and veterans' service organizations in a collaborative manner to affect these important changes that were informed during the prior meetings.

This is an unprecedented action by MOAA to communicate directly with the president on our broad array of policy objectives – possibly signaling a welcome change in our relationship with this administration.

### Day One Message to the Force from Sec-Def Lloyd J. Austin III

*I am honored to have this chance to serve again and to do so alongside you and your families. My wife, Charlene, and I know all too well the sacrifices you make to keep this country safe. That safety is job one, and I promise to work as hard as you do at it.*

*The way I see it, my job as Secretary of Defense is to make you more effective at doing yours. That means ensuring you have the tools, technology, weapons, and training to deter and defeat our enemies. It means establishing sound policy and strategy and assigning you clear missions. It means putting a premium on cooperation with our allies and partners. And it means living up to our core values, the same ones our fellow citizens expect of us.*

*Right now, of course, doing my job also means helping our country get control of the pandemic, which has killed more than 400,000 Americans. You have already come to the aid of our Nation's health care professionals. You can expect that mission to continue. But we must help the Federal Government move further and faster to eradicate the devastating effects of the coronavirus. To that end, we will also do everything we can to vaccinate and care for our workforce and to look for meaningful ways to alleviate the pressure this pandemic has exerted on you and your families.*

*None of us succeeds at this business alone. Defending the country requires teamwork and cooperation. It requires a certain humility, a willingness to learn, and absolute respect for one another. I know you share my devotion to these qualities.*

***I am proud to be back on your team.***

### **First Lady Jill Biden to Relaunch Military-Focused *Joining Forces* Initiative**

The Joining Forces initiative was established to bring together the private sector, nonprofit organizations, and local state and federal programs to support troops, veterans, families and caregivers. The effort focused initially on improving opportunities for and supporting military spouses as well as military personnel and expanded to address transition issues and veteran employment. Military advocacy organizations reacted joyfully to this announcement. MOAA was actively involved with this Initiative in the Obama Administration and continues its advocacy for military families, spouses, and caregivers.

### **Joint Chiefs of Staff Address the Violent Rioting of January 6<sup>th</sup> on the US Capitol.**

In a powerful message to the Joint Force on January 12, the JCS condemned the actions of those involved as a direct assault on our constitution, inconsistent with the rule of law, and characterized those violent actions as sedition and insurrection.

*“The American people have trusted the Armed Forces of the United States to protect them and our Constitution for almost 250 years. .... As Service Members we must embody the values and ideals of the Nation. We support and defend the Constitution. Any act to disrupt the Constitutional process is not only against our traditions, values and oath, it is against the law.”*

### **Do you know expectations for MOAA members as described in the Resolutions?**

Excerpted from MOAA Resolutions as approved at the 2020 Annual Meeting.

The preamble to MOAA's Bylaws, articulates the patriotic values held by the Association which serve as guiding principles for all endeavors. Membership in MOAA comes with the expectation that members exhibit strong personal character, consistent with values in those By-Laws and the

principle of “*officership as a life-long profession.*”

We share a fundamental and continuing responsibility to setting an honorable example of public service, protecting the interests and welfare of our nation and of our fellow citizens.

Through our oath of “office” we swear to support the fundamental tenets of our constitution - the rule of law, justice-for-all, and treating every individual with respect and dignity.

In accepting our commission, we assent to honor the special trust and confidence given to us:

*“reposing especial trust and confidence in your patriotism, conduct, and fidelity in defense of American Liberty”*

### **Florida Representative Waltz introduces plan to eliminate Tricare premiums for adult children under 26.**

A proposal to allow adult children to remain covered under their parents’ Tricare plan until age 26 — without having to pay an extra premium for a separate Tricare plan — was introduced in Congress by Rep. Michael Waltz, R-Fla. and Rep. Elaine Luria, D-Va. on Jan. 25.

H.R. 475, titled, “**Health Care Fairness for Military Families Act of 2021,**” would eliminate the requirement to pay a separate premium for a young adult. That would save some families \$459 a month. As of Jan. 1, monthly premiums increased by 22 percent, to \$459 for those in Tricare Young Adult Prime; and by 12 percent, to \$257, for those in Tricare Young Adult Select. By law, the Tricare Young Adult programs must be at no cost to the government, under the rules set when it was implemented in 2013. *Consequently, the full cost of the program’s premiums is reflected in the fees charged to families.*

The Bills co-sponsors say this legislation is a matter of equity. Military families using Tricare don’t have the same ability to keep their children on their health care plan until age 26, unlike other health care plans as required by the Affordable Care Act.

Currently, dependent children can remain on their parent’s Tricare plan until age 21, or until age 23 if the child is enrolled in a full course of study, and the sponsor is still providing more than half of their financial support. At age 23, the child may qualify to purchase Tricare Young Adult.

More than 37,000 unmarried, adult children of military sponsors were enrolled in either the Tricare Young Adult Prime or Select programs as of a year ago, according to the Defense Department.



## To Maintain Military Dominance, Don't Skimp on our Service Members

Lt. Gen. Dana T. Atkins, USAF (Ret), president and CEO of MOAA, stresses the importance of rewarding servicemembers for their performance – not just at the bare minimum as part of efforts to shrink budget figures, but in a way that recognizes their talents and encourages others to join their ranks. The following appeared in the *Hill News* on January 31, 2021:

The defense of our nation depends on the Defense Department's ability to recruit and retain the best our country has to offer. Even under ideal situations, that's a tall order.

And these are not ideal situations. Research puts the total recruiting pool of 17- to 24-year-olds at 20 million individuals but, of those, only 465,000 are fit to serve, mentally and physically, according to Department of Defense (DOD) data. The military needs about 260,000 such Americans each year. Even worse: 55 percent of parents discourage their sons or daughters from military service, the data show.

Retention brings its own concerns. As the saying goes, "You recruit the soldier, but you retain a family." In recent years, that part of military retention has included poor base housing conditions, inadequate programs to battle spouse unemployment, multiple long deployments, and long child care wait lists.

The Military Officers Association of America (MOAA) and other military and veterans advocacy groups have fought for programs to improve both the recruitment and retention prospects of our all-volunteer force. But even those that have taken effect have come at an unfair cost, with resources shifted from an existing program to cover a new priority. In effect, budget-makers are robbing one group to support another by requiring a "pay for" — a proposed source of funds — for any bill requiring new funding.

Some examples:

- Vietnam veterans exposed to toxic defoliants such as Agent Orange while at sea — so-called "Blue Water Navy" vets — received long-sought relief in 2019, but with funds generated by an increase in Veterans Affairs (VA) home loan processing fees.
- When the Special Survivor Indemnity Allowance (SSIA) was about to expire, Congress tapped the beneficiaries, via increased pharmacy copays, to fund the provision that spared that allowance.
- Programs designed to trim budgets or find efficiencies regularly do so by passing along the pain points to beneficiaries. The move to public-private housing has resulted in congressional hearings and a series of missteps, all at the expense of military families. Moves to realign the Defense Health Agency may have the well-intentioned purpose of

an efficient medical system, but they could result in retirees and family members seeking care in an over-stressed civilian health system as dozens of on-base options disappear.

Sadly, these examples aren't the worst-case scenarios. Recent history is replete with budget moves that take from beneficiaries without boosting other DOD or VA programs. One example: MOAA and other groups successfully fought off a 2013 law that would have cut the cost-of-living increase for retirees by 1 percent, with disastrous results: A retiring E-7 would have lost \$83,000 before reaching age 62, and an O-5 would have lost \$124,000 for the same period.

And for three years (2014-2016), the Obama administration undercut the legislated military pay raise by a cumulative total of 2.6 percent to fund other programs. Service members are still feeling the effects of these cuts — and will for decades throughout their retirement. New recruits, meanwhile, often cite pay and benefits as the No. 1 reasons for signing up. ***So these persistent erosion incentives will have strategic consequences that I don't believe our nation is in a position to accept.***

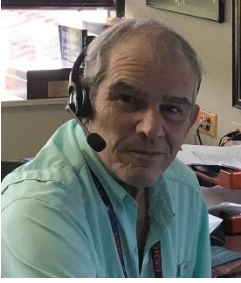
There are many more examples of budget-makers attempting to compensate the personnel who make up our military — not by encouraging or rewarding their service, but by squeezing their benefits to just above the breaking point ... they hope.

Our service members are our No. 1 weapon system. We must, as a nation, come to terms with what it costs to have a dominant defense capability. Continued fiscal maneuvers such as the ones noted here will impact retention — and the word will get out to those who are considering military service.

## Personal Affairs

In a two week period in 1976, I got commissioned, got married, and got my first USAA auto insurance policy.

Forty-four years later, I'm retired from the Marine Corps, still married, and still sending money to USAA.

Initially, they mailed me a bill and I'd mail them a check. I can't remember if they went online or set up auto pay first, but for probably the last twenty years, USAA would email me a monthly statement, and once or twice a month debit my checking account.

This automatic debit, in which the customer sends a voided check to the vendor is technically called an "Automatic Clearing House" payment or more simply, an "ACH debit."

Odds are very good that you have multiple vendors using ACH debits to collect your monthly bill. As I've got my main property insurance policy with USAA, they debit my checking account for that. I've also got a life insurance policy, for which they debit my checking account monthly, too. Then, I've got a USAA Visa card, which was also set up for ACH debit.

Needless-to-say, the abbreviation "USAA" appears on my checking account statement a lot. A couple years ago, I happened to look at my checking account a little closer than I normally do. It took me a while to figure out that my checking account had an extra debit from USAA. Huh? I pulled out several months of checking account statements, and matched them to my USAA accounts.

Son-of-a-gun... there was definitely an extra payment each month. Sometimes two.

I called USAA. The customer service person did some investigating and one of the payments was going to a USAA checking account, then being transferred to a credit union in Arkansas. Say what?

I had no knowledge of that checking account. It was a scam.

Somebody had set up an account in my name at USAA and was debiting my personal checking account to get cash.

I was soon in contact with the Fraud people at USAA. They shut down the bogus USAA account. I changed all of my passwords, not only with USAA, but with every vendor with whom I have a relationship.

In talking to the USAA Fraud people, they explained that I was a victim of "ACH debit fraud." Somebody got the numbers off the bottom of my checks and started debiting my checking account. Wow.

USAA was great in that they immediately refunded me all of the money that had been fraudulently taken from my checking account.

Amazingly, about two weeks later, I received a call at work from a woman in Oklahoma. She Googled me and found me at my work. A check that I had sent her had bounced. Huh? I explained that whoever gave her that check was a thief. She sent me a copy of the check which had my name printed on it and a totally different signature.

I connected with USAA Fraud again. They were not particularly interested in pursuing it. I was in Florida. USAA is in Texas. The money was sent to Arkansas, then apparently sent all over. They had already moved on.

I did a little research. ACH debit fraud is a very fast growing form of fraud. The problem is... every time you give a personal check to someone, you give them the routing number for your bank and your banking account number. When you do auto pay (ACH debit), they also have your bank routing number and your bank account number.

A fraudster with those two numbers can easily start debiting your checking account.

It turns out that there's a much safer way. All banks nowadays offer a service called "web-bill-pay" or something to that effect. The big advantage is that the only account number that goes with your payment is the account number with the vendor. In practical terms, when you use web-bill-pay to pay FPL, the people at FPL, get your FPL account number but not... your checking account number.

Actually, for major vendors, such as FPL, Verizon, AT&T, Century Link, or Comcast, the payment is done electronically.... which is even safer. For not-major vendors (think your landscaper), they get a paper check in the mail. The numbers across the bottom of the check they receive are those of your bank, not your personal checking account.

There's an added benefit in web-bill-pay. If you ever decide to fire Verizon and switch to AT&T, you simply turn off your web-bill-pay to Verizon. You... are totally in control. To turn off that ACH debit, you must connect with the vendor and get them to turn it off. It's amazing how hard it can be to terminate ACH debiting once it's started.

At this point, I try extremely hard to not send a check to anyone. The only time I give anyone an actual check is if it's a one-time payment and they are not set up to accept a credit card payment.

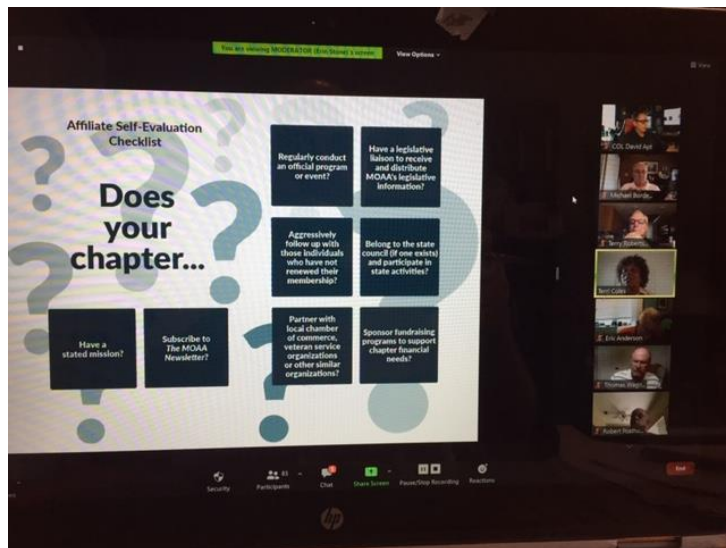

I would like to introduce your first 2021 State Legislative “homework” assignment to make your voice be heard to support **Senate Bill SB586 SkillBridge Program** to help our military service personnel transitioning to civilian life. Please refer to the last paragraph for detailed instructions on how you can contact your respective legislator.

**Department of Defense (DoD) SkillBridge Program** is the best kept secret in the Military! Florida State Senator Tom Wright (R-New Smyrna Beach) chairs the Senate Military and Veterans Affairs, Space and Domestic Security Committee. Sen. Wright filed Senate Bill **SB 586 SkillBridge** which creates a statewide awareness and employment program built on the DoD SkillBridge Program. There is no companion House Bill at present. Sen Wright's office added "SkillBridge will connect transitioning servicemembers to employers and their new career path. During the transition period, the servicemembers' salary and benefits are retained while obtaining any associated industry certifications."

The DoD SkillBridge program is an opportunity for Service members to gain valuable civilian work experience through specific industry training, apprenticeships, or internships during the last 180 days of military service. The program allows service members to gain workforce training at private businesses while on active duty as they are transitioning out of the military. To **apply** for a DoD SkillBridge Career Skills Program, Service Members should go to <https://dodskillbridge.usalearning.gov>

**Veterans Florida** has been designated as the state's principal SkillBridge assistance organization to employers and transitioning service members and will implement the SkillBridge program throughout the Sunshine State. *Veterans Florida* ([www.veteransflorida.org](http://www.veteransflorida.org)) is a non-profit organization created by the Florida Legislature to help military veterans' transition to civilian life, and to promote Florida's status as the nation's most veteran-friendly state. *Veterans Florida* provides powerful tools for veterans to take advantage of the benefits of living and working in the Sunshine State. The POC is Jeremy Sinnemaki at email address [sinnemaki@veteransflorida.org](mailto:sinnemaki@veteransflorida.org) and (850) 296-1553.

**Veterans Florida Executive Director Joe Marino wholeheartedly supports this program and said** "We thank Senator Wright for his dedication to military families by introducing this important legislation. Veterans Florida is committed to connecting transitioning servicemembers with DOD SkillBridge opportunities throughout Florida."

The Florida Department of Veterans' Affairs (FDVA) Deputy Executive Director James S. "Hammer" Hartsell agrees this is a worthwhile program and said "The DoD SkillBridge Program provides a pipeline of veteran workforce talent to Florida's high-tech industries straight from within our 21 Florida military bases. *Veterans Florida* is uniquely qualified to lead the state's efforts creating awareness of the program's opportunities with employers and service members and their families."

MOAA has been authorized by the Office of the Deputy Assistant Secretary of Defense through official Memorandum of Understanding to work with each of the applicable branches of the military Services and respective installation commanders to develop SkillBridge training programs for their personnel.

### Governor Ron DeSantis' Florida Leads Budget Strongly Supports Florida's Veteran Community

**TALLAHASSEE** – Gov. Ron DeSantis' Florida Leads budget provides critical support to the state's 1.5 million veterans, their families and survivors.

Florida Department of Veterans' Affairs Deputy Executive Director James S. "Hammer" Hartsell said: "I'm very proud of Governor Ron DeSantis' steadfast support of FDVA, ensuring Florida remains the most veteran-friendly state in the nation. Governor DeSantis has committed millions of dollars in funding to Florida's veteran population over the past two years. This year's budget continues our passion of connecting veterans with their earned services, benefits and support."

One of the biggest enterprises within the FDVA is its network of award-winning State Veterans' Homes. The State of Florida boasts six state veterans' nursing homes and one state veterans' domiciliary. Additional state veterans' nursing homes in Port St. Lucie and Orlando are slated to open in calendar year 2021.

Governor DeSantis has proposed funding for the completion and staffing of the additional state veterans' nursing homes in Port St. Lucie and Orlando, and capital improvements and replacement of equipment and furniture for the state's operational veterans' nursing homes and domiciliary.

Other state veterans' home funding includes support for contract services for increased costs and utilization in agency staffing, housekeeping, therapy, medical and pharmacy services.

The Florida Leads budget provides \$350,000 for a veteran suicide prevention outreach program. Florida is a role model and leader in the "Governor's Challenge to Prevent Suicide Among Service Members, Veterans and their Families," a national call to action asking state, military and civilian interagency teams to embark on a process of collaborating, planning and implementing suicide prevention best practices and policies for service members, veterans and their families statewide.

The Governor's Florida Leads budget also continues funding for Florida is for Veterans, Inc. (*Veterans Florida*). *Veterans Florida* is a non-profit created by the State of Florida to help military veterans transition to civilian life and to promote Florida's status as the nation's most veteran-friendly state.

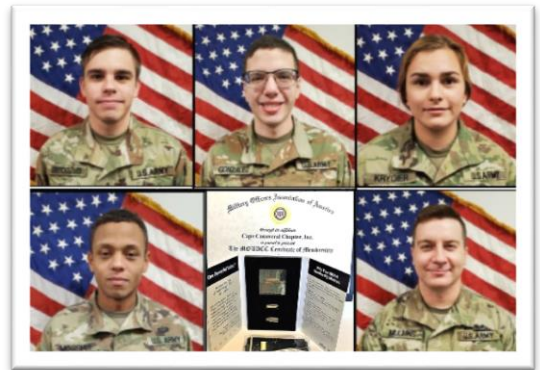

### Rough Weather for No-Dough-Dinner To-Go Feeding Mayport Area Active Duty Enlisted Military Families

Thanks to funds provided by the MOAA Foundation through a Community Outreach Grant, Historic Mayport Chapter teamed with USO Mayport to prepare several hundred “Sloppy Joe” dinners for active duty enlisted military members and families in the Mayport, Florida area.

A team of USO and Chapter volunteers worked the morning of Tuesday 26 January 2021 and the morning of the next day cooking, chopping, and filling containers to prepare for pre-registered active duty enlisted military members and families to pick up meals in a drive-thru format outside USO Mayport.

Before COVID struck, families would dine at No-Dough-Dinners (NDD) inside the USO Mayport facility. However, with COVID precautions in place the USO / MOAA team have pivoted to an NDD To-Go format, which follows CDC and local guidelines for face coverings and distancing.

On Wednesday 27 January 2021, bags were ready to be packed with complete meals, drinks, deserts and bread or pastry for the number of adults and children in each family. Tags on the bags identified the family, number of meals, and expressed MOAA and USO's appreciation for their service.

As cars arrived at the pre-arranged time slot, service I.D. cards would be verified for the proper name and the checker would confirm the number of meals expected. The pre-bagged food for each family would be delivered with no-contact between the delivery team and the recipient(s).

Historic Mayport Chapter had nine volunteers signed up to help the USO Mayport Team with the delivery and were asked to report at 3:30 pm with the deliveries to start at 4:00 pm on Wednesday 27 January 2021 at USO Mayport.

The Chapter USO liaison had been at USO Mayport since 10:00 am helping and the Chapter President arrived at 2:00 pm.

After 2:30 pm the weather appeared to be worsening and the temperature was noticeably dropping. At 3:00 pm the USO Director expressed concern to the Chapter President about Chapter volunteers working outside for food delivery. At 3:10 the Chapter President began calling volunteers and asked them to please stay at home for safety. At 3:30 pm two volunteers arrived and agreed to help the Chapter President and Chapter USO liaison to work inside to bag and convey family meals to the USO team working outside to deliver the food to the families who could make it to USO Mayport in the storm.

Just prior to 4:00 pm a down pour started that rivaled what I had experienced during the late summer tropical monsoon season in the Philippine Islands. Heavy rain continued throughout most of the NDD To-Go time slots. Although many arrived, some families could not make it including one family of nine.

USO Mayport had been in contact with a cadre of 200 United States Marines who were in quarantine in the local area in preparation for deploying on a mission. With a large amount of food remaining from the event, USO Mayport contacted the Marines and they were anxious to pick up the leftover food for their troops.

With USO Mayport’s help nothing went to waste and we accomplished our mission of helping feed active duty enlisted military members and families.

### HLAA Member Eloise Schwarz addresses MOAA

Eloise E Schwarz was the keynote speaker for the January 6<sup>th</sup>, 2021 local Military Officers Association of America (MOAA) Membership Zoom meeting.

A member of the Hearing Loss Association of America (HLAA) since 2004, Eloise encourages everyone to join this one-of-a kind organization if they have any difficulty with hearing.

Hard of hearing since birth, she wasn’t aware of it until she turned 50 years old while working for an insurance company. She could hear sound but never understand what was spoken, which is a common occurrence with hearing loss.

Life dealt her harshly because of her hearing loss – she elaborated on why she is passionate on teaching others about preserving their hearing before it’s too late.

She joined the local HLAA chapter in Milwaukee WI, so that she could find others who shared the same difficulties as she experienced daily. She became a leader at the local level and soon joined the WI State HLAA Board of Trustees, serving from 2008 to 2014.

She was appointed by then Governor Doyle to serve on his WI Council of the Deaf and Hard of Hearing for three years from 2008 to 2011. Additionally, she was appointed by the Mayor of Wauwatosa to serve on the Committee for Citizens with Disabilities from 2008 to 2011.

A new name was given the Chapter - The Metro Milwaukee Chapter and started in 2013. It continues with a new Board of Directors, after she left in 2019 for Florida to retire.

When she arrived in Sun City Center, the chapter here was nearing closure. The National office was due to take over and close the chapter. Eloise notified the Office in Maryland and worked to start the chapter once again.

The HLAA SCC Chapter has not closed during this pandemic, it has just taken on a new method of doing business.

Eloise discussed ways to communicate if you have hearing problems. In particular commenting on people who can hear the sounds of speech but cannot recognize what is being said. In that regard she emphasized but did not limit her discussion to communication techniques; coping skills; technology improvements; and the laws that have made hearing a disability.

She said there are 48 million people in America with hearing deficiencies and 2.7 million veterans who, not surprisingly, have hearing loss and tinnitus.

# Military Officers Club of Volusia County

1LT Raymond ("Ray") A. Parker, USA (Ret), First Vice President

Currently, in many schools across Volusia County, formal programs do not exist to bring military veterans into the classroom. Accepting and implementing the *VOLUSIA VETERANS IN CLASSROOMS* (VVIC) program enables faculty and students the opportunity to draw upon the broad and deep personal knowledge, skills, and abilities of veterans to supplement and enhance patriotism.

MOCVC performed an informal needs assessment. The MOCVC First Vice President, who has direct experience with such programs, canvassed local school students, selected faculty, veteran organization members and leaders, and the Volusia County Schools Specialist, 6-12 Social Studies, for current status and candid evaluation of such a program's value and success potential. This preliminary due diligence garnered helpful information, and more importantly, demonstrated keen interest in such a program and the value it can bring. Teaching professionals acknowledged the Florida Statute and indicated that value can be derived from utilizing veterans.

## VOLUSIA VETERANS IN CLASSROOMS ("VVIC")

### PURPOSE AND SCOPE

The purpose of this proposal is twofold: to introduce the Volusia County School Board, other Volusia school leadership, and school personnel to the value of utilizing Volusia County military veterans in classrooms and; to secure approval of a proposal to utilize military veterans to supplement and enhance student patriotism as presented across schools in Volusia County.

### ABSTRACT

#### What

Local veteran groups seek to provide and coordinate appropriate area military veterans to assist instructional staff in encouraging patriotism by furnishing veterans to speak with students on their military experiences and other Americanism programs, as appropriate.

#### Why

Florida Statute for required instruction, 233.061, Section 2 (r), encourages patriotism by engaging the assistance of local military veterans in classrooms on or before Veterans Day and Memorial Day.

#### Who

At the discretion of Volusia County Schools (VCS) and other Volusia schools, enrolled students in grades 6-12, will participate in the program in conjunction with the respective school curriculum, generally in the realm of social studies/history.

Selected and vetted military veterans from local organizations such as the American Legion, AmVets, Disabled American Veterans, Jewish War Veterans, Marine Corps League, Military Officers Association of America, Military Order of the Purple Heart, Veterans of Foreign Wars, Vietnam Veterans of America, and others, will serve as a cadre of veteran presenters.

For 2021-2022, the Military Officers Club of Volusia County (MOCVC) will plan, organize, implement, and oversee the program through the Volusia County Veterans Council (VCVC) for participating veterans. Volusia County Schools, public and private, in coordination with a Volusia County School District 6-12 Curriculum Specialist, will liaise with the VCVC to implement in-classroom presentations. Throughout planning, the MOCVC First Vice President will coordinate with the VCVC Commander. The MOCVC and VCVC will foster the program with Volusia County Schools via the 6-12 Curriculum Specialist.

Volusia County Schools: Curriculum Specialist, 6-12 Social Studies, Volusia County Schools, DeLand, FL

### Where

The Volusia Veterans In Classrooms program is intended for use across educational institutions throughout Volusia County. Presentation is for in-class settings, in-person or virtual. MOCVC and VCVC will coordinate programs through a VCS curriculum specialist.

### When

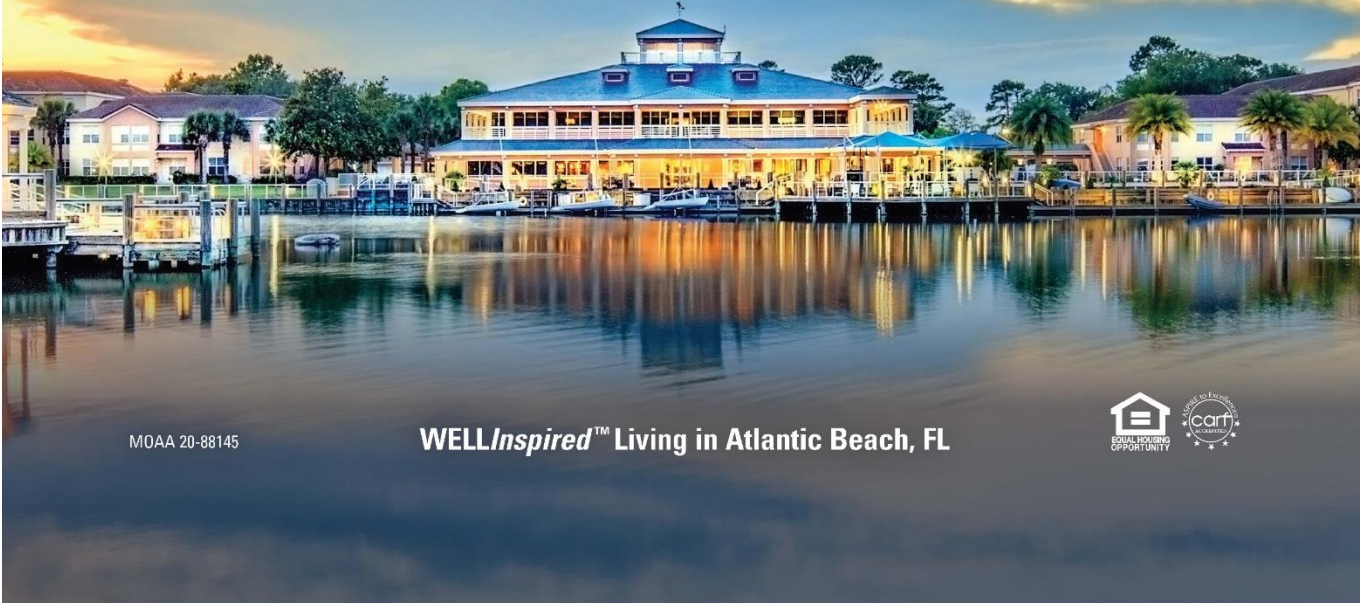
