- **Leadership Training Seminar (LTS):** Registration opens this month for the LTS to be held January 26th – 27th at the Rosen Centre Hotel in Orlando. The LTS is one of the most important tasks we have as a Council—to train Chapter Leaders. This LTS will be different from those in the past as MOAA’s new leadership training format has changed. Now chapter leaders will receive MOAA orientations in virtual seminars, while the focus of our annual, in-person LTS will be centered on chapter health. We will form small groups around our seven state areas to discuss the “how to” of running chapters and develop plans to grow membership and build healthy chapters. Preparation will be required and the takeaway from the LTS will be a plan for your chapter for 2024. Chaplain's Message

I'm writing this on the Feast of St. Michael and All Angels – September 29th – and reflecting on the Archangel Michael's place in the world's faiths and militaries. Michael is one of seven archangels in the Jewish tradition and serves as the protector of Israel and commander of the angelic forces. Michael is an interfaith archangel: referenced in Islam, the Orthodox tradition, the Roman Catholic tradition, and in many Protestant traditions. The following is a classic prayer for St. Michael's protection:

Saint Michael the archangel, defend us in battle. Be our protection against the wickedness and snares of the Devil. May God rebuke him, we humbly pray, and do thou, O Prince of the Heavenly hosts, by the power of God, cast into Hell Satan, and all the evil spirits who prowl about the world, seeking the ruin of souls.

Michael also figures prominently in military traditions around the world, especially as the patron saint of paratroopers. The beret insignia of the French paratroopers, for example, is a winged arm grasping a dagger, representing Saint Michael, and Michael is the patron of Italian Special Forces.

For US paratroopers, St. Michael figures prominently in the lore of D-Day, especially the 82nd Airborne's combat jump at Normandy. Several Normandy churches, most especially St. Mere Eglise, feature stained glass windows dedicated to US paratroopers and St. Michael. In addition, the 82nd Airborne Chapel at Ft. Liberty (formerly known as Ft. Bragg) includes a St. Michael window.

I first learned about St. Michael's connection with paratroopers while at jump school many years ago. Our chaplain participated in every one of our five training jumps and led brief devotionals for those interested before every training jump. He introduced St. Michael's Jump Commands (modelled after the standard airborne jump commands) at one of those devotions:

Get ready! I will always attempt to be spiritually fit before my Maker.

Stand up! I will decide to maintain high moral standards despite what others say or do.

Hook up! I will maintain a direct line of communication with my God through prayer and worship.

Check static line! I will make a daily check about attitudes and relationships with others.

Check equipment! I will take an inventory of my weaknesses and faults and try to amend them.

Sound off for equipment check! I will share my faith with others by word and example.

Stand in the door! With my belief and trust in God, I will determine to face bravely whatever test life gives me.

Go! Whether on land or in the air, I will be firm in my resolutions to serve God and country as both would expect me to do.

Surviving Spouse Corner

Know your State Benefits!

Florida is an extremely friendly state in many respects, but especially in regulations that benefit Surviving Spouses.

If you own a home, you should qualify for the homestead exemption. If you are widowed, there is an additional exemption. Each additional exemption has eligibility requirements and requires that an application be filed at your County Property Appraiser's Office. The deadline is March 1.

Also I recommend that each of you get a copy of "Florida Veterans' Benefits Guide 2023" and read it. Surviving spouses, who have not remarried, are allowed to continue receiving their veteran's benefits in many circumstances. A few examples are listed and quoted below:

Education Benefit: There are scholarship opportunities for spouses (and dependent children) of veterans who died from a service-connected disability. Visit www.floridafinancialaid.org or call Florida Department of Education 888-827-2004.

Property Tax Exemptions: The unremarried surviving spouse of a disabled ex-service member having a VA certified disability of 10 percent or greater is entitled to a \$5,000 deduction on the assessment of her/his home.

Any real estate owned and used as a homestead by the surviving spouse of an Armed Forces member who died from Service-connected causes while on active duty is exempt from taxation, if the member was a permanent resident of Florida on January 1 of the year in which the member died.

If, upon the death of the veteran, the spouse holds the legal or beneficial title to the homestead and permanently resides there, the exemption from taxation carries over to the benefit of the veteran's spouse until such time as he/she remarries, sells, or otherwise disposes of the property. If the surviving spouse sells the property, an exemption not to exceed the amount granted from the most recent ad valorem tax roll may be transferred to the new residence as long as it is used as the primary residence and the spouse does not remarry.

Any partially disabled veteran who is age 65 or older, any portion of whose disability was combat related, and who was honorably discharged, may be eligible for a discount from the amount of ad valorem tax on the homestead commensurate with the percentage of the veteran's permanent service-connected disability. Apply at the County Appraiser's office. The benefit carries over to the Surviving Spouse.

State Employment and Promotion Preference: The state and all political subdivisions of the state, shall give preference in employment and promotion to....

The unmarried widow or widower of a veteran who died of a service-connected disability.

Review the specifics above. If you are eligible, act now to gain the benefits your veteran earned for you.

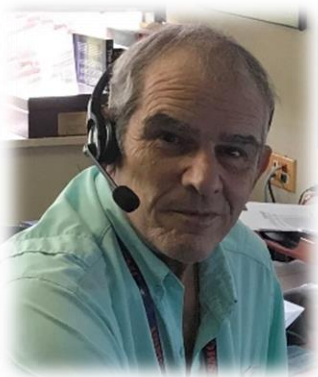

Required Minimum Distributions

The average age of members in MOAA Chapters is supposedly 73, which, coincidentally, happens to be the age one must start taking money from retirement accounts. These distributions are officially known as Required Minimum Distributions, or most often called “RMDs.”

So what... is an RMD?

Basically, if you ever put money into an IRA or a 401k or the federal Thrift Savings Plan, you put it in pre-tax and the government says “it’s time to start paying taxes on it.”

How much must one take? They use a “single life expectancy table” which says that at age 73, your life expectancy is 26.5 years. For the year in which you turn 73, you take the value of your retirement account on January 1 and divide it by 26.5. An easier way of saying that is you must take out 3.77% of the value of the account on January 1. At age 80, your life expectancy is 20.5 years, or you must distribute 4.95% of the value of the account on January 1. By age 90, it’s 12.2 years or 8.19%.

In English, this means that the percentage you must withdraw increases every year and the percentage increases at an increasing rate. If you have your investment account invested wisely, the value of the account should also increase... your yearly RMD should increase every year. It’s a *great* problem to have.

What happens if you don’t do your RMD? The penalty used to be ridiculous. Now, it’s merely onerous. Starting this year, it’s a 25% penalty on the amount you were supposed to withdraw. If

you are 73 and have \$100,000 in a retirement account, your RMD is \$3,773.58. Miss it and the penalty could be \$943. Ouch.

Incidentally, I always round up. If you happen to do the \$3,773 in the example above and miss the 58 cents, the paperwork will drive you nuts. Much better to do \$3,800. It also makes the arithmetic much easier.

Some more incidental items: if you have more than one retirement account, it's the total amount in all the accounts that counts. You may pull all the dollars for all the RMDs from one account. Of course, the financial institution that's holding your IRA from which you withdraw zero might drive you nuts encouraging that you do your RMD because they have no way of knowing how much you have at brand X, but there's no requirement that you do a RMD from each account.

There's also no requirement that you withdraw *dollars*. If you own investments in your IRA, you may withdraw *shares* of investments. Let's say you have shares of Microsoft in your IRA that you bought at \$180 a share several years ago. It's now about \$325 a share and you like it. You could sell some shares and withdraw dollars and then buy back the Microsoft in a normal account. Or... you could withdraw 12 shares and save the trading commissions. The cost basis for those shares becomes the price on the day of distribution.

A problem with withdrawing shares is that you cannot withhold *shares* for taxes. You can simply do an estimated payment if you're concerned about it.

Another incidentally: It's a "minimum" distribution. You may do *more*. As a financial advisor at Merrill Lynch, I had two hundred clients who needed to do RMDs. Only a handful withdrew significantly more than the minimum.

Does it matter when you do it in the year? After years of looking, I could find no good reason for a better or worse time to make it happen. I could find no tax or investment reason to do it in January or December. I did try to get all RMDs done by December 1 so that it shows on the November statement. That gives you December to correct any problems. Keep in mind that the number of business days in December are typically less than other months and it's likely that many employees will be off starting around the twentieth. It's not a good time to be scrambling to get something big done. You definitely want it done by December 15.

What happens if one passes on while there's still money in a retirement account?

If you are married and your spouse is your primary beneficiary, it goes to your spouse and the spouse gets to continue doing RMDs based on the *spouse's* age. (If you're 75 and your spouse is 45, there are different rules...). If you are not married, the account goes to your beneficiaries. Since 2020, the rules changed so that your beneficiaries do *not* have to do yearly RMDs, but they do have just *ten* years in which to withdraw the full amount.

This can be a real attention-getter and I'm sure it will be starting in 2027 or 2028 when some beneficiaries start realizing that they have two or three years to withdraw significant amounts of dollars which count as taxable income. If your beneficiaries are in their forties or fifties, and making serious money, realizing that they have a year or two to withdraw several hundred thousand dollars from retirement accounts may be frustrating. The last thing they might need is a huge increase in taxable income. This is where it might make more sense *for the family* for you to do more than the

minimum.

Some people consider rolling the assets into a Roth IRA, which is an option. If you do this, the amount you roll is then a taxable distribution. This guarantees that you will pay significantly more in income taxes now, while creating a tax-free pot of money for your beneficiaries. They still have ten years to withdraw it all out after you pass on, though it will be tax-free to them. Though one could make a rational argument in favor of this strategy, I'm unenthusiastic. I'd rather see the beneficiaries arrange their affairs to try to minimize the tax bite on withdrawals. As many accountants will say, a "tax deferred is a tax not paid."

One other suggestion: if you have accounts at several financial institutions, *combine* them. Each has its own paperwork and passwords, and when somebody else must do something with those accounts, it can be a real pain.

I lost track of how many times I had somebody say "I still have 401Ks at my old jobs." And when my son was in college, he worked in the call center for the American Funds. He found a screen that had tens of thousands of "abandoned" accounts. These were accounts where American Funds lost contact with the owner.

In my career, I often heard people say "I don't want to put all my eggs in one basket." I'd respond "which is more likely to occur: Merrill Lynch (or Wells Fargo or USAA or Navy Federal or JP Morgan) fails... or *you* pass on? They almost always started the process of combining their accounts. During the process, I often asked "See how complicated this is? How would your non-financially savvy spouse handle this?"

I need to add a disclaimer: Tax law is complicated and a continuously moving target. Be sure to consult with your financial advisor or accountant before making specific decisions.

Final note: I've been writing this column for the last couple years while wearing *handcuffs*. As an employee of Merrill Lynch, I was not allowed to write about anything *financial*. I retired from Merrill in August, so the handcuffs are off. I spent thirty-five years as a financial advisor leading a team that managed over a half billion dollars in assets. I also managed two branch offices and trained rookie advisors for five years. There's very little that I have not seen.

2024 FCoC Convention Update

If all goes according to plan, the FCoC will have the web site for registering for the 2024 Convention up and running by early February. For those who want to arrive early then registration and hospitality will open at 4 PM on Sunday. This would be a wonderful time to settle in and take advantage of the hotel's amenities, the Azure Oceanfront restaurant, the Oceanview Lounge, and of course the Tiki Hut barefoot beach bar. It would also be a fine time to explore Daytona Beach and seek out the many fine restaurants on offer.

Monday the 13th will be the official start of the convention with registration and hospitality opening at 9 AM. Interested attendees will have an opportunity for tours of Embry Riddle Aeronautical University on Monday and Wednesday mornings. The first FCoC Board Meeting will be at about 3 PM and attendees are welcome to attend this meeting as observers if not an official board member. The traditional President's Reception will start at 6 PM in the first-floor ballrooms. A cash bar will be available and there will be hors-d'oeuvres. Following that we plan to have a MAGIC & COMEDY SHOW that should start about 8 PM.

Tuesday will be the heaviest day for activities. Registration and hospitality will open at 10 AM after the FCoC Business Meeting scheduled for 8 AM. The traditional Memorial Service will be held at 9 AM followed by BRUNCH. I encourage you all to take to opportunity to come to the brunch as we plan to have two speakers who will provide insights that are not in the usual scope of FCoC or MOAA talks.

The normal FCoC and MOAA presentations will follow brunch. For those who are looking for something different or for spouses who are not particularly interested in FCoC/MOAA presentations there will be the opportunity to go to an Afternoon Tea at a local heritage center. The Planners have also met with the local craft spirit distillers to provide samplings of their products which are rum and vodka. More on these opportunities later.

The big event of Tuesday will be the Military Ball. There will be a pre-dinner reception on the top floor of the hotel with excellent views of the beach, the ocean, and the Halifax River.

Attendees will need to make their way down to the main ballrooms for the start of the Ball at about 7 PM.

The actual timing of all the events will need further refinement and there might be some changes to the schedule, but I hope you have some idea of what will be in store for you at this wonderful event. An event that provides you the opportunity to gather with your fellow MOAA members and celebrate another great year.

I'd like to remind you that we have arranged for attendees to extend their stay at the Shores for two extra days at the same price as the convention days. In future Communiques I will provide information about what else there is to do in the Daytona area and I sincerely hope you will take advantage of this special opportunity to stay beyond the convention, relax in the oceanfront splendor of the Shores Resort and Spa, and enjoy the "World Famous" Daytona Beach.

Congress Lurches Toward a Government Shutdown

*For each of the past 27 years, the FY began on October 1st with either a **Continuing Resolution** or a **Shutdown**, reflecting the difficulty in getting the most important funding and authorization bills through the legislative process. **Three** of the ten government shutdowns going back to 1983 have occurred since 2013.*

The past two weeks have been one of the most divisive and disruptive periods in congressional legislative history. And now with just a week to go before the government shuts down and threatens troop paychecks, Congress has no clear path to passing any spending bill.

Before the Senate left for the weekend and the Jewish high-holidays, Senate Majority Leader Chuck Schumer, took procedural steps to ready the chamber to act on its own CR if the House remains paralyzed when they return. With the Senate showing their hand like this, it increases the likelihood that the House will muster enough votes for passage on the Senate Bill with democratic support.

In the meantime, our military and their families are considerably worried that they will miss paychecks to cover daily expenses for food, housing, day care, travel and other routine expenses. Thankfully, several financial institutions with ties to the military community are working on offering bridge loans to alleviate some of this burden on military families.

But the failure in the House to agree on any options to move forward underscores this stark reality:
Congress is careening toward a government shutdown with no solution.

Tell Congress to Pay Our Troops

As the start of a new fiscal year draws closer with no agreement in place to fund the government, servicemembers, veterans, and their families face uncertainty, financial stress, and an erosion of trust in their lawmakers – all during a recruiting and retention crisis for the all-volunteer force. Lt. Gen. Brian T. Kelly, USAF (Ret), MOAA president and CEO had plenty to say about the impacts of a government shutdown:

*“Military members and their families volunteer and are honored to serve and make the needed sacrifices, but they don’t and should not expect to sacrifice their financial security, The all-volunteer force is the backbone of our nation’s national and economic security. We depend on them and hold them accountable ... **they want and deserve the same**”*

dependability and accountability from the elected members of Congress who are charged with supporting them ...Government shutdowns and uncertainty of pay and benefits directly contribute to our current recruiting crisis.

The **Pay Our Troops Act HR 5641** would protect military servicemembers and certain Department of Defense civilian employees, contractors and Coast Guard personnel should Congress fail to reach an agreement on a Continuing Resolution in time to prevent any disruption to covering the costs of housing, food security, childcare, medical expenses and other routine daily costs. Congress has grappled with passing timely annual appropriations for a quarter-century; this year is not any different, and it's **critical for our members to let their lawmakers know that change is long overdue.**

Our Senators have indicated their support for this measure, but they still need to be urged to rally their colleagues and see that this bill reaches the finish line and is signed into law. A more direct request is needed for our House delegation.

Even if a CR does pass to avoid a shutdown, it will have a deadline just a short time downstream. HR 5641 will extend the protection until a permanent funding bill is passed.

Florida Veterans Council Update

Florida Veterans Council**

The Florida Department of Veterans' Affairs (FDVA) is a government agency of the State of Florida under the authority of the Governor of Florida and is charged with helping 1.5 million Florida veterans and their families to receive all benefits they are legally entitled to. In addition, FDVA operates a network of nine State Veterans' Homes, and provides statewide outreach to connect veterans with their earned services, benefits, and support. In 2022, FDVA Veterans' Claims Examiners assisted more than 272,000 veterans in providing information and counsel on benefits they rightly deserved.

The department is headed by an Executive Director (MG retired James "Hammer" Hartsell) with a deputy executive director over four divisions (Administration, Veteran's Benefits, Information Technology and Veterans' Homes) and three directors (General Counsel, Legislative Affairs and Communications).

Each year the FDVA publishes the **Florida Veterans' Benefits Guide** to provide resources to Florida veterans and their families. I highly encourage you to read and/or download the **2023 Guide** at <https://floridavets.org/> or just click here 

For **bulk copies** of the 2023 *Florida Veterans' Benefits Guide*, email Leeann.Sferrazzarios@fdva.fl.gov. For single copies of the 2023 *Florida Veterans' Benefits Guide*, email Mary.Frazier@fdva.fl.gov.

In addition to the Benefits Guide, I encourage you to go to the same website and sign up for the monthly newsletter to keep up to date on all the latest news and updates. To stay in touch with FDVA, you may also download their new **FDVA Mobile App**.

Need to file a claim or find out what your benefits are? Information on current federal, state, and local veterans' programs, entitlements and referral services is also available in Florida through a network of County Veteran Service Offices. Counselors are trained and accredited annually by the FDVA. All services are provided **free of charge**. A list of offices near you can be found online at www.floridavets.org/benefits-services

The Sunshine State is home to the second largest population of **Women Veterans** in the nation, with more than 164,000 who call Florida home. In May 2022, I led a 14-member fact-finding Committee on Florida Women Veteran Benefits and Communications and presented a formal report to the Executive Director of the FDVA. In short, many women veterans don't know that they earned and are eligible for the full range of federal and state benefits, to include special programs for them.

I am proud to announce that I am now the Vice Chair of this very unique and one-of-a-kind counsel that catches the eyes and ears of the FDVA Executive Director MG (ret) Hartsell. Other Veteran Services Organizations include (but are not limited to) the American Legion, AMVETS, Disabled American Veterans, County Veterans Services Officers Association of Florida, Jewish War Veterans, Military Order of the Purple Heart, Paralyzed Veterans of America, Veterans of Foreign Wars, and Vietnam Veterans of America. During our council meetings we are briefed by Steve Murray on FDVA updates, Roy Clark updates on Florida Legislative Affairs, Vanessa Thomas on Women's Initiatives, and a report from Denise Baker on the Florida Veterans Foundation. In addition, we have speakers who update us on topics such as Veterans Treatment Court (DJ Reyes) and the Governors Veteran Suicide Challenge (Jeff Obos). We then open the meeting for our counsel representatives to discuss issues that are for the good of the counsel. Topics can range from identifying potential veteran legislation, housing issues, homelessness, state run nursing homes, counsel support of specific veteran issues that need to be raised to a higher level, and others that are specific to a Veteran Service Organization. Answer to the Quiz

Both of these dates, which occur in the month of October, celebrate the men and women of the United States Navy, past and present. The Navy celebrates its birthday officially on October 13 and Navy Day was established to be observed on October 27. There is a difference between the two, starting with the fact that the Navy Birthday is recognized on the anniversary of the historic formation of the Continental Navy during the American Revolution. Navy Day was originally chosen to coincide with the birthday of President Theodore Roosevelt. Which Came First?

Navy Day is actually the older observance, in terms of when it was created and officially recognized as it is today. The "official" observation of the Navy birthday was initiated by Admiral Elmo Zumwalt in 1972, but Navy Day was sponsored by the Navy League of New York in 1922. While both holidays recognize the service and sacrifices of those in uniform, Navy Day is specifically about military service, where the Navy birthday celebrates the origins and history of the U.S. Navy.

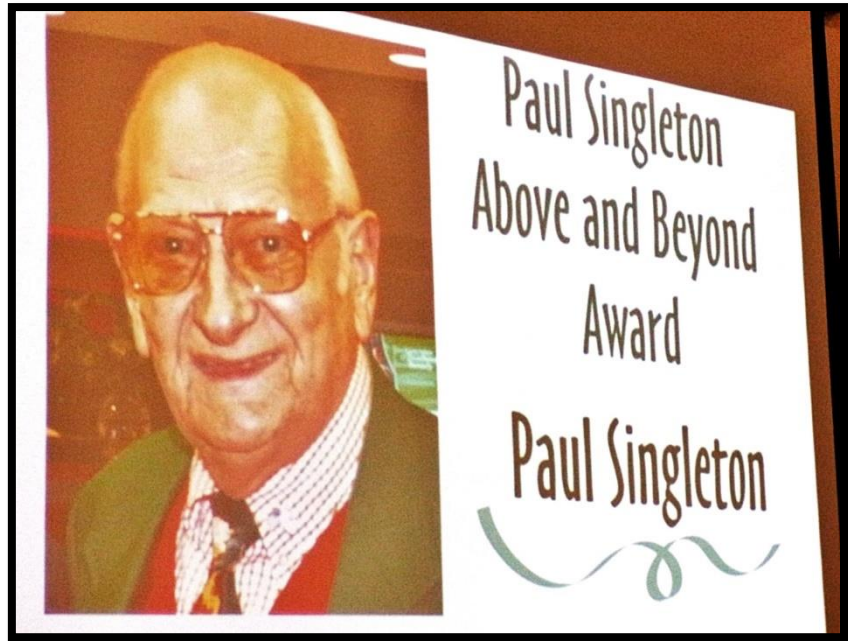

Chapter Member Honored by Chamber of Commerce

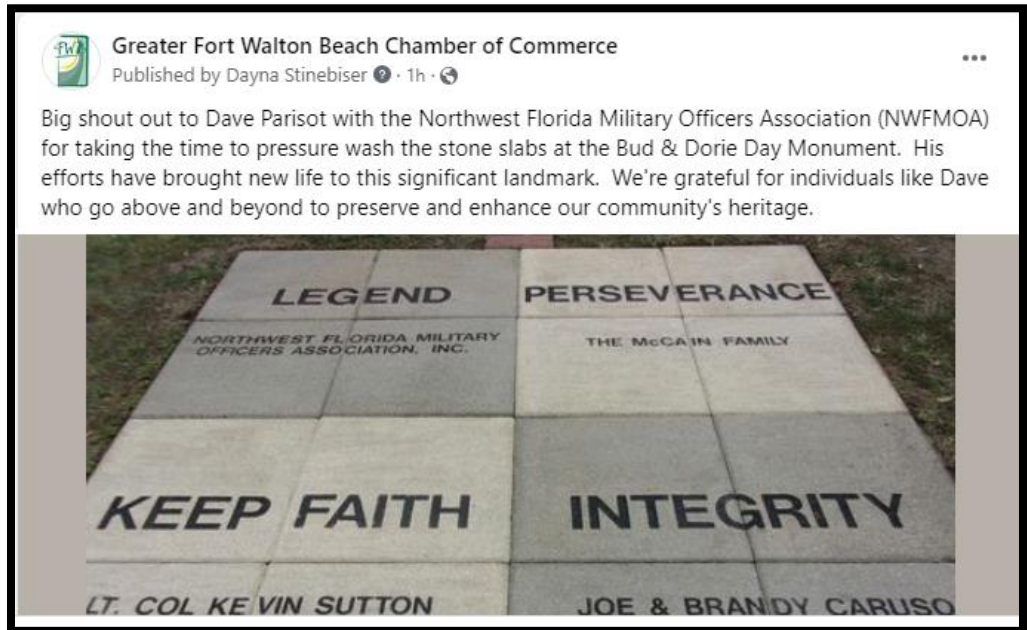

The project’s services are free. However, it does not provide legal advice, assist with legal proceedings, or provide legal services or legal representatives. Any case involving a criminal offense is turned over to the proper law enforcement agency for appropriate action.

The project accepts cases where one party to the conflict is a Florida resident or Florida business. If no party involves Florida, the project will not take the case. Most of the cases involve Florida seniors.

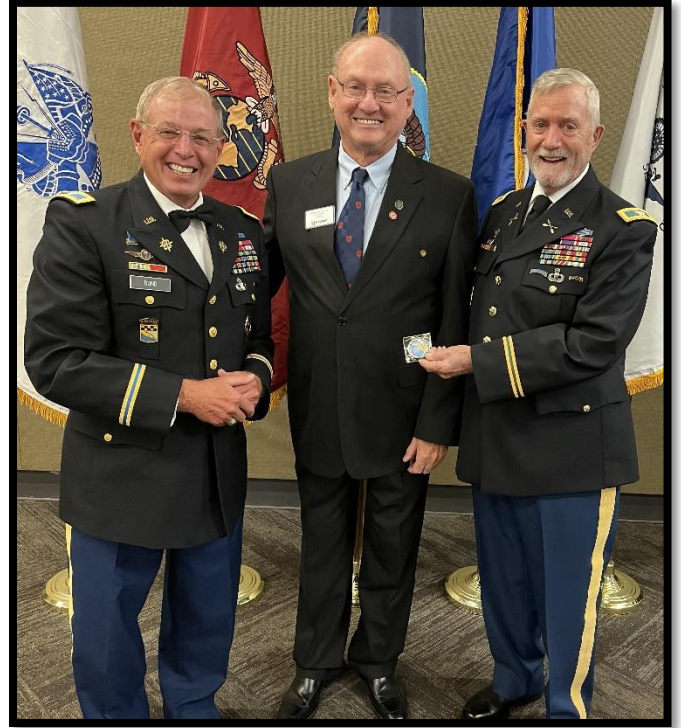

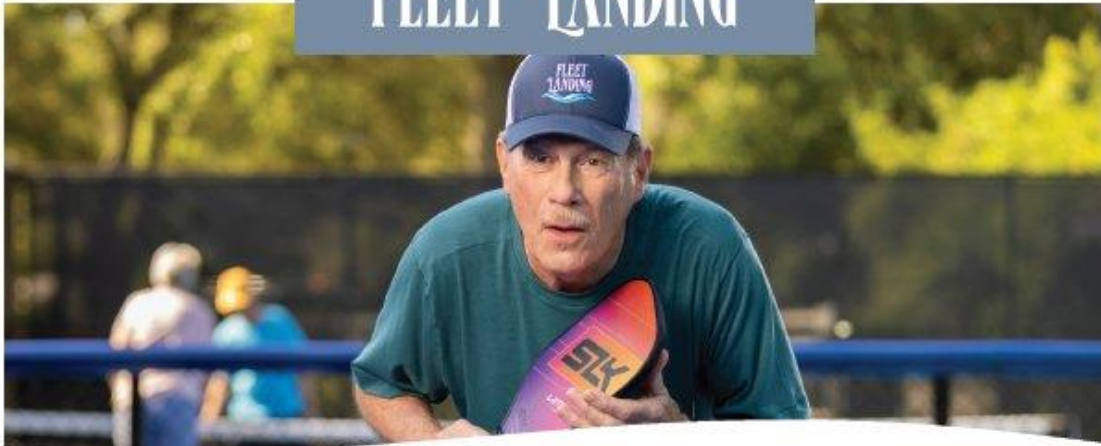


And Last but not Least
