We also were approached by the VA Clinic management to contribute to the "Wall of Heroes" with a plaque of our organization (an artist rendering can be found at the end of this message). As I outlined at the January luncheon, several military veteran organizations were approached for this project by the VA Clinic. Secretary's Report – December Board of Directors' Meeting

Secretary's Report – January 2, 2024 - Board of Directors' Meeting

The January 2024 Board of Director's Meeting for the Halifax Chapter of MOAA met on January 2, 2024, at the Halifax Yacht Club, in Daytona Beach, FL. The meeting was called to order by Andrew Hoffman at 10 a.m.

The following board members (showed with an asterisk) and guests were present: Andrew Hoffman*, Bancroft McKittrick*, Tina Dixon-Bartlett*, Lon Gardener*, Don Needham*, Skip Keating*, Steve Maas*, Patti Higgins*, and Steve Becker.

Quorum requirements met.

Old Business

The following items were discussed:

1. **The minutes of the December 2023, Board of Directors meeting** - were distributed by email during December. Acceptance of these was nominated, seconded, and approved via email.
2. **Treasurer's Report** - Lon Gardener summarized the report and said that the current checking balance is \$4514.41. There is \$150 in petty cash, making a total balance of \$4664.41. Lon stated that there were seventy-two attendees at the gala. Lon also mentioned that Kevin Tobias, the Gala DJ, has been receiving the same compensation, \$350, for 6 years. Kevin's usual compensation is \$150 per hour. Carl and Billie Krueger have been personally adding a gratuity of \$50 to each check. Lon suggested that we consider increasing Kevin's compensation. After much discussion, it was recommended that this item be tabled until we have a Gala chairperson and committee, and they could provide us with a recommendation. Don Needham made a motion to accept, Bancroft McKittrick seconded, and all approved.
3. **Membership** – Steve Becker stated there were no new members added in December. At the end of 2023, we had a total of 127 members. Drew Hoffman mentioned that each chapter is asked to self-report the total number of members and sent FCOC \$0.75 per member.
4. **Officer Call** – The January Officer's Call has been emailed and is packed with valuable information.
5. **Surviving Spouse Update** – Patti Higgins mentioned that a couple of surviving spouses attended the gala. She also stated that she read an article which discussed support for recurring benefits for surviving spouses.
6. **Bagels and Bingo** – Skip Keating stated that they met yesterday and there were six volunteers and eighteen veterans present. This activity takes place at Emory Bennett Veterans Nursing Home in Daytona Beach at 10 am on the first Monday of each month.
7. **VCVC Update** – Skip Keating stated that we had five members attend the "Wreath Across America" activity at Lohman's cemetery. It was suggested that we participate again this year. He also mentioned that the WWII exhibit at the Museum of Arts and Sciences (MOAS), 352 S. Nova Rd, Daytona Beach is here through January 21, 2024. It is free to veterans.
8. **VA Coffee and Donuts** – Patti Higgins stated they did not provide coffee and donuts in December because there was another event scheduled at their usual time. They will be at the facility this Thursday.
9. **FCOC Leadership Development Training** – Drew Hoffman mentioned that the leadership seminar will be held January 24-26, 2024, in Orlando. He states that the seminar would be beneficial for all members. So far, Drew Hoffman, Bancroft McKittrick, Patti and John Higgins, and Pierre Louis are planning to attend. The FCOC annual convention will be in May at Daytona Beach Shores Resort.
10. **HRYC Pricing and 2nd Half 2024 Menu** – The price for the monthly MOAA luncheon has increased to \$27 per meal. The menus for 2024 are planned through May. The menus for September through December will be selected later this year.

New Business

11. **Outstanding Dues** – There are sixty-three members with a renewal date of 12/31/23. It was suggested that an email be sent to those members. Bancroft McKittrick and Steve Becker stated that they would make calls to those members who still have not paid after receiving the email.
12. **Holiday Gala Chair** – There has been no one that has volunteered to be the chairperson for the gala. Billie Krueger has been the chair for the last few years. Bancroft stated that he would ask her about doing so again this year.

From The Floor

- 13. January Luncheon Speaker** – Dr Paul Johnson will be the speaker for the January luncheon. He will be speaking on Hyperbaric Therapy. He is currently a Flight Surgeon and State Surgeon for the Montana Army National Guard. Dr. Johnson is passionate about veteran’s health, especially TBI/PTSD.
- 14. Leadership Books and MOAA Coins**– Drew Hoffman stated that Kim Ramos has ordered more books, and we have plenty for the year. Lon Gardner stated that we have plenty of coins. The monthly speaker receives a gold coin, and the cadets are given ceramic coins.
- 15. Outstanding Support Award Committee** – Bancroft McKittrick mentioned that the committee is canvassing for groups to present an award for their support of veterans. The committee consists of Ben Taylor, Skip Keating, and Bancroft McKittrick.
- 16. Monthly Speakers** – Don Needham will be looking for speakers for our upcoming meetings and Skip Keating asked him to consider Embry-Riddle professors. Don will meet with Billie for more information on the process of attaining speakers.

The meeting was adjourned at 10:43 a.m. Our next meeting is on February 6, 2024.

Legislative Affairs/National MOAA Advocacy in Action

This month, I wanted to take the time to remind members to visit www.moaa.org and spend some time getting to know the Legislative Action Center again. This section was mentioned quite a few times at our recent FCOC Leadership Training in Orlando. The Legislative Action Center is a section on the national website that gives members the tools they need to effectively advocate for policy. This center is the most important part of our work to change policies that affect the benefits that veterans, current duty military (including the National Guard and Reserve), former officers, and their families have earned. Some of the most important things about the Legislative Action Center are:

1. The center keeps members up to date on important legislative problems that affect them. Members can get a better sense of the issues at stake by reading analyses of current bills, policy ideas, and government actions.
2. Members are notified quickly when important changes happen in the law. There are often calls to action in these alerts, telling members to talk to their chosen officials about important issues right away.
3. The platform has a number of tools that can help with lobbying. This includes notes and emails that have already been written and can be sent directly to lawmakers, as well as advice on how to talk to policymakers effectively and set up and run meetings with elected officials.
4. Members can see how MOAA's most important advocacy efforts are going. The center gives people up-to-date information on how new laws are doing in Congress, such as vote counts, bill amendments, and referrals to committees.
5. Members can make their advocacy efforts more specific by using the available tools. Members can find out how to get in touch with their individual congressional representatives, personalize their messages, and share personal stories or insights that show why the legislation being considered is important.
6. The Legislative Action Center of MOAA is also an educational resource. It has articles, webinars, and other materials that help members stay up to date on policy problems and advocacy strategies that affect the military.
7. The center invites members to work together and build communities. Members can have a bigger effect on policy decisions when we work together in a collective team for advocacy activities.

The Quorum area is the most important part of the LAC. This area shows a more advanced and data-driven part. It is a legislative tracking program that gives you actions taken and next level information so, we can keep an eye on and change the way policies are made. When it's added to the Legislative Action Center, it makes it much easier for us lobby in a number of ways:

1. Members can keep an eye on military-related bills at some stages of the legislative process. This means keeping an eye on things like new bills, changes to existing bills, committee orders, and votes on the floor. This is done by following the source links that are listed on the site.
2. The platform has strong analytics tools that look at data from the legislature. This can include things like sponsorship and co-sponsorship, and how likely it is that a bill will be passed.
3. The section, if used properly, can showcase the most important people in the legislative process, like committee members, and other groups whose goals are similar to yours.

4. National MOAA can get its members to move quickly by telling them about important legislative moments. For example, they can be told to call their representatives or join advocacy campaigns.
5. MOAA can use Quorum to make unique reports about changes in the law, the results of their lobbying efforts, and how involved their members are. This information is very important for figuring out how well their strategies are working and making choices based on facts.
6. Quorum makes it easier to talk to lawmakers in a focused way. If members wants to, they can use the platform to write and send lawmakers and their staff personalized messages, position papers, or testimonies about certain legislative problems.
7. The section can be used to teach members how laws are made, how to talk to lawmakers in a good way, and the details of current laws that affect the military.

4 August 1945 – 2 November 2023



Husband of LTC Tina Dixon-Bartlett, US Army Retired. Richard James Dixon-Bartlett passed away on 2 November 2023. He was 78 years old and was born on 4 August 1945, in Buffalo, NY. Richard graduated from Corning/Painted Post High School and went on to attend Corning Community College for 2 years. Upon leaving college, he went to Rittners Floral Design School and became a Floral Designer.

In 1964, Richard was drafted into the US Marine Corps, and he served in Vietnam as a Combat Engineer. Returning from Vietnam, he joined the Army Reserves and served for 4 years.

Richard spent over 40 years working as a Floral & Interior Designer, managing shops in 8 states. He designed floral pieces for weddings, funerals, large hotels, party boats, etc. For over 15 years, he participated in designing floral designs for Los Angeles Home and Garden Shows, and he created floral designs for the Rose Bowls Parade floats.

Richard loved to be in nature and near the ocean. He was extremely creative and crafty; his home always looked like a showplace. He enjoyed making friends wherever he went. He is survived by his wife of 35 years, Tina Dixon-Bartlett, 3 sisters, and his brother. A military honors & interment event was held at the Cape Canaveral National Cemetery, Mims FL on 18 January 2024.

Plus, let's remember the sacrifice of 3 US soldiers killed 28 January in Jordan, and more than 40 other service members who were injured in a drone attack at a military base near the Syrian border. Those service members were in Jordan to support Operation INHERENT RESOLVE, the US & coalition mission to ensure the defeat of ISIS.

The three soldiers killed are SGT William Jerome Rivers of Carrollton GA; SPC Kennedy Ladon Sanders of Waycross GA; and SPC Breonna Alexsondria Moffett of Savannah GA. All three were assigned to the 718th Engineer Company, 926th Engineer Battalion, 926th Engineer Brigade, Fort Moore GA.

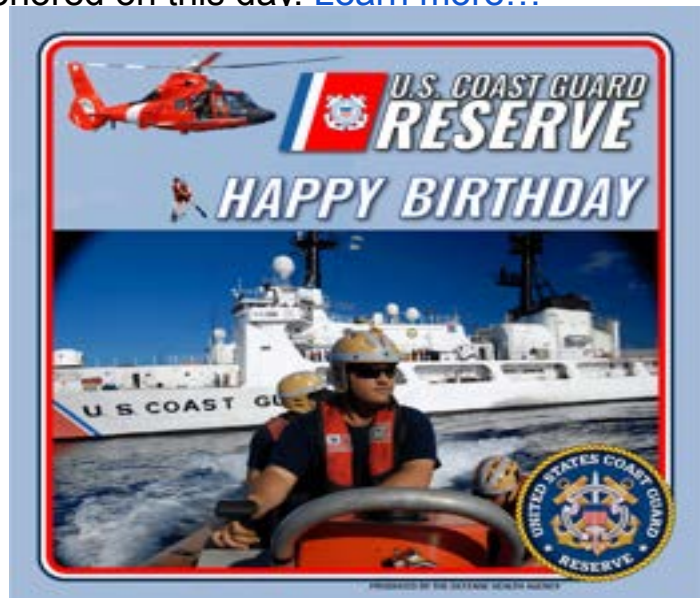
