The checking account had a May Luncheon expense of \$441.79 and Deposits totaling \$637.50, which represented Luncheon proceeds, dues .and Mercer Advertisement Ad check. A motion was made and seconded to accept the Treasurer's report; all approved. The Treasurer's report was accepted as submitted.

**Membership Report –** No Change – We have 61 Regular members, 14 Surviving Spouse Members and 34 Spouse Members

On the Dues report we did make a correction indicating 63 paid members adding Bob Radford who paid at the May Luncheon and Andrew Rodnite who had paid Jane back in March of 2021 for his 2022 dues.

Rob is going to send a Blast to Non- Paid Members to see if they are planning on paying their 2022 Dues as the March 31 deadline has passed. Those not responding with a dues payment will be purged from our rolls.

**Web Report**: Rob indicated that the intermittent errors that show up on the reservation web site appear to be "user" error. He has personally tested the site and found no issues.

**Drumbeat Report** – It was decided that for the summer there will be a combined edition of the Drumbeat. One edition going out late July for the months of July and August as not much happens during our summer hiatus.

Spouse/Surviving Spouse Report - Nothing to report at this time.

**Legislative Liaison** – Dave Apt reported that Congressman Bilirakis's district will no longer encompass Clearwater. His District will cover Pasco Hernando and Citrus Counties. We will not know who our Congressional Representative will be until after the mid-term elections in November so we are presently in a wait and see
