MOAA FCoC Leadership Training Seminar, 26-27 January 2024 Rosen Centre Hotel, Orlando Florida

The MOAA Florida Council of Chapters (FCoC) Leadership Training Seminar for State and Chapter leaders is being held from 26-27 January 2024, at the Rosen Centre Hotel in Orlando, Florida. We are expecting approx. 200 participants, including Council and Chapter leaders from our 39 chapters throughout Florida, representatives from adjacent States, and members of the MOAA Staff from the Washington D.C.
